Three of the persons filing this report, Merrill Lynch & Co., Inc., a Delaware corporation with its principal place of business at World Financial Center, North Tower, 250 Vesey Street, New York, New York ("ML&Co."), Merrill Lynch Group, Inc., a Delaware corporation with its principal place of business at World Financial Center, North Tower, 250 Vesey Street, New York, New York ("ML Group"), and Princeton Services, Inc. a Delaware corporation with its principal place of business at 800 Scudders Mill Road, Plainsboro, New Jersey, ("PSI") are parent holding companies pursuant to (S)240 13d-1(b) (1) (ii) (G). ML&Co. may be deemed to be the beneficial owner of common stock of Freeport McMoran, Inc. (the "Company") held by or deemed to be beneficially owned by ML Group and MLPF&S.

MLPF&S, a wholly-owned direct subsidiary of ML&Co. and a broker-dealer registered under Section 15 of the Securities Exchange Act of 1934, holds certain of the reported securities in proprietary trading accounts and may be deemed to be the beneficial owner of the reported securities held in customer accounts over which it has discretionary power.

ML Group, a wholly-owned direct subsidiary of ML&Co., may be deemed to be the beneficial owner of 13.8% of the common stock of the Company by virtue of its control of its wholly-owned subsidiary, PSI and certain Merrill Lynch Trust Companies, each of which is a wholly-owned subsidiary of ML Group and a bank defined in Section 3 (a) (6) of the Securities Exchange Act of 1934.

PSI, a wholly-owned direct subsidiary of ML Group, may be deemed to be the beneficial owner of 13.8% of the common stock of the Company by virtue of its being the general partner of MLAM and FAM.

MLAM, a Delaware limited partnership with its principal place of business at 800 Scudders Mill Road, Plainsboro, New Jersey, is an investment adviser registered under Section 203 of the Investment Advisers Act of 1940. MLAM may be deemed to be the beneficial owner of 13.6% of the common stock of the Company by virtue of its acting as investment adviser to several investment companies registered under Section 8 of the Investment Company Act of 1940.

One registered investment company advised by MLAM, Merrill Lynch Growth Fund for Investment and Retirement (the "Fund"), may be deemed to be the beneficial owner of 13.5% of the common stock of the Company.

FAM, a Delaware limited partnership with its principal place of business at 800 Scudders Mill Road, Plainsboro, New Jersey, is an investment adviser registered under Section 203 of the Investment Advisers Act of 1940. FAM may be deemed to be the beneficial owner of less than 5% of the common stock of the Company by virtue of its acting as investment adviser to several investment companies registered under Section 8 of the Investment Company Act of 1940.

Except as provided above as to certain securities of the Company held by MLPF&S in proprietary trading accounts, pursuant to (S)240.13d-4, ML & Co., ML Group, MLPF&S, the Merrill Lynch Trust Companies, PSI, MLAM, FAM and the Fund disclaim beneficial ownership of the securities of the Company, and the filing of this Schedule 13G shall not be construed as an admission that any such entity is, for the purposes of Section 13(d) or 13(g) of the Securities Exchange Act of 1934, the beneficial owner of any securities of the Company.
