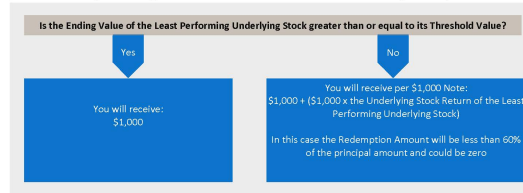
Terms of the Notes

The Contingent Income Auto-Callable Yield Notes Linked to the Least Performing of the Common Stock of Costco Wholesale Corporation, the Common Stock of International Business Machines Corporation and the Common Stock of Morgan Stanley. (the "Notes") provide a monthly Contingent Coupon Payment of between \$7.0834 and \$7.9167 (set on the pricing date) on the applicable Contingent Payment Date if, on the related monthly Observation Date, the Observation Value of each Underlying Stock is greater than or equal to its Coupon Barrier. Beginning in July 2020, if the Observation Value of each Underlying Stock is greater than or equal to its Starting Value on the relevant Observation Date occurring each quarter, the Notes will be automatically called, in whole but not in part, at an amount equal to 100% of the principal amount, together with the relevant Contingent Coupon Payment. No further amounts will be payable following an Automatic Call. If the Notes are not automatically called, at maturity you will receive the Redemption Amount, calculated as described under "Redemption Amount Determination".

Threshold Value:	For each Underlying Stock, 60% of its Starting Value.
Contingent Coupon Payment [†] :	If, on any monthly Observation Date, the Observation Value of each Underlying Stock is greater than or equal to its Coupon Barrier, we will pay a Contingent Coupon Payment of between \$7.0834 and \$7.9167 per \$1,000 in principal amount of Notes (equal to a rate of between 0.70834% and 0.79167% per month or between 8.50% and 9.50% per annum) on the applicable Contingent Payment Date (including the Maturity Date). The actual Contingent Coupon Payment will be determined on the pricing date.
Automatic Call:	Beginning in July 2020, all (but not less than all) of the Notes will be automatically called if the Observation Value of each Underlying Stock is greater than or equal to its Starting Value on the relevant Observation Date occurring each quarter. If the Notes are automatically called the Early Redemption Amount will be paid on the applicable Contingent Payment Date.
Early Redemption Amount:	For each \$1,000 in principal amount of Notes, \$1,000 plus the applicable Contingent Coupon Payment.
Initial Estimated Value Range:	\$920-\$940 per Note.
Underwriting Discount [*] :	\$32.50 (3.25% of the public offering price) per Note.
