The Contingent Income Auto-Callable Yield Notes Linked to the Least Performing of the Common Stock of Apple Inc., the Common Stock of JPMorgan Chase & Co. and the Common Stock of McDonald's Corporation (the "Notes") provide a monthly Contingent Coupon Payment of 58.9584 on the applicable Contingent Payment Date if, on the related monthly Observation Date, the Observation Value of **each** Underlying Stock is greater than or equal to its Coupon Barrier.
