Item 1 Security and Issuer

This Amendment No. 2 (this "Amendment 2") amends, as set forth below, the statement on Schedule 13D, dated September 27, 2022 and filed with the SEC on September 29, 2022 (the "Original Schedule 13D"), as amended by Amendment No. 1 dated April 20, 2023, and filed with the SEC on April 24, 2023 (the "Amendment 1"), for Bank of America Corporation ("BAC") and Banc of America Preferred Funding Corporation ("BAPFC") (collectively, the "Reporting Persons") with respect to the Series A MuniFund Preferred Shares (CUSIP 670686401) ("MFP Shares") of Nuveen Enhanced High Yield Municipal Bond Fund (the "Issuer" or the "Company").

This Amendment 2 is being filed solely to report a change of the percent of class beneficially owned by the Reporting Persons due to the outstanding shares of the preferred class of the Issuer increasing to 1,395 shares as identified in Form NPORT-P filed with the SEC on February 27, 2024, by the Company.

The Reporting Persons are currently analyzing their additional trading activity in securities of the Issuer and expect to file another Schedule 13D amendment as promptly as reasonably practicable once that analysis is complete.
