Summary Terms

The Notes:

- The Notes are designed for, but not limited to, investors (i) who anticipate that the level of the Utilities Select Sector Index (index symbol “IXU”) (the “Index”) will decrease from the starting value of the Index on the pricing date to the ending value of the Index determined on the valuation dates shortly prior to the maturity date of the Notes or (ii) who, for risk diversification purposes, want to invest in such a security. Investors must be willing to forego interest payments on the Notes and accept a return that may be less than the \$10 original public offering price per unit and will not exceed the limit described in the attached offering document.
- There will be no payments on the Notes prior to the maturity date and the Notes cannot be redeemed prior to the maturity date.
- There is no principal protection on these Notes and therefore an investor will not receive a minimum fixed amount at maturity.
- The Notes are made available to each investor outside of the United States in a minimum initial investment of US\$50,000 (US\$75,000 for residents of the European Economic Area), and subject to any other restrictions, as may be applicable to an investor under the private offering rules of any jurisdiction outside of the United States.
- We have applied to have the Notes listed on the American Stock Exchange under the trading symbol “UZW”. If approval of this application is granted, the Notes will be listed on the American Stock Exchange at the time of such approval. We make no representation, however, that the Notes will be listed, or, if listed, will remain listed for the entire term of the Notes.

- The Notes will be senior unsecured debt securities of Merrill Lynch & Co., Inc., and part of a series entitled “Medium-Term Notes, Series C”. The Notes will have the CUSIP No. .
- The settlement date for the Notes is expected to be August , 2007.

Payment on the maturity date:

- The amount an investor receives on the maturity date will be based upon the direction of and percentage change in the level of the Index from the starting value to the ending value. If the level of the Index:
 - has decreased, on the maturity date an investor will receive a payment per unit equal to \$10.00 plus an amount equal to \$10.00 multiplied by triple the percentage decrease of the Index, up to a maximum total payment which will be between \$11.75 and \$12.15 per unit, as described in the attached Offering Document.
 - is unchanged or has increased by 10% or less from the starting value, an investor will receive \$10.00 per unit.
 - has increased by more than 10% from the starting value, an investor’s original investment will be reduced based upon the percentage increase of the Index in excess of 10% from the starting value. In no event will an investor’s return be less than zero.
- The actual maximum total payment on the Notes will be determined on the pricing date and set forth in the final offering document made available in connection with sales of the Notes.

The Notes, the subject of the attached offering document (the “Offering Document”), have not been approved for public sale in any jurisdiction outside of the United States. As such, the Notes are made available to investors outside of the United States only in accordance with applicable private offering rules. The Offering Document may not be copied or otherwise made available to any other person by any recipient without the express written consent of Merrill Lynch & Co., Inc. (the “Company”).

No Prospectus (as defined in the EU Prospectus Directive) will be prepared in connection with the Notes. Accordingly, the Notes may not be offered to the public in any European Economic Area member state and any purchaser of the Notes who subsequently sells any of their Notes in any EEA member state must do so only in accordance with the requirements of the Prospectus Directive as implemented in that member state.

The discussion contained in the Offering Document relating to the tax implications of investing in the Notes is not based upon, and does not reflect, the tax laws of any jurisdiction outside of the United States. Accordingly, investors should consult their local tax advisor before making an investment in the Notes.

Subject to this Notice, the Offering Document has been approved for issue in the United Kingdom by Merrill Lynch International Bank Limited ("MLIB"), which is authorized and regulated by the Financial Services Authority, with a registered office at Merrill Lynch Financial Center, 2 King Edward Street, London EC1A 1HQ, United Kingdom. This Notice is issued in Hong Kong by Merrill Lynch (Asia Pacific) Limited.

Investors in the United Kingdom should be aware that Merrill Lynch, Pierce, Fenner & Smith Incorporated ("MLPF&S"), which is handling the sale of the Notes, has no place of business in the United Kingdom and is not regulated by the Financial Services Authority. Therefore, with respect to any action taken by MLPF&S, the regulatory regime governing an investor's rights will be different than that of investors' rights in the United Kingdom, and the United Kingdom rules for the protection of private investors and the United Kingdom Financial Compensation Scheme will not apply to any business MLPF&S conducts with or for United Kingdom investors.
