#### General

- The Notes are designed for investors who seek early exit prior to maturity at a premium if both the S&P 500 Index and the Dow Jones EURO STOXX 50 Index are at or above their Call Levels on any Review Date. If the Notes are not called, investors are protected against up to 10% decline of either or both Indices on the final Review Date but will lose some or all of their principal if either or both Indices decline by more than 10%. Investors should be willing to forgo interest payments and, if either or both Indices decline, be willing to lose some or all of their principal.
- The first Review Date, and therefore the earliest call date, is September 23, 2008.
- The Notes will be senior unsecured debt securities of Merrill Lynch & Co., Inc. ("ML&Co."), maturing September 28, 2010.
- The Notes will be issued in denominations of \$50,000 and integral multiples of \$1,000 in excess thereof.
- The Notes are expected to price on or about September 13, 2007† and are expected to settle on or about September 18, 2007.

#### **Key Terms**

Indices: The S&P 500 ® Index and the Dow Jones EURO STOXX 50 SM Index (each an "Index" and collectively the "Indices")

Automatic Call: If the Index closing level for each Index on any Review Date is greater than or equal to the applicable Call Level, the Notes will be automatically called for a cash payment per Note that will

vary depending on the applicable Review Date and Call Premium.

Call Level: 90% of the Initial Index Level for each Index for the first Review Date. 90% of the Initial Index Level for each Index for the second Review Date (if applicable). 100% of the Initial Index

Level for each Index for the final Review Date.

Payment if Called: For every \$1,000 principal amount Note, you will receive one payment of \$1,000 plus a call premium (the "Call Premium") calculated as follows:

• at least 15.00%\* x \$1,000 if called on the first Review Date

• at least 30.00%\* x \$1,000 if called on the second Review Date (if applicable)

at least 45.00%\* x \$1,000 if called on the final Review Date

\*The actual percentage applicable to the first, second, and final Review Dates (if applicable) will be determined on the Pricing Date but will not be less than 15.00%, 30.00%, and 45.00%,

respectively

If the Notes are not called and a mandatory redemption is not triggered, your principal is protected at maturity against up to a 10% decline of either Index or both Indices. If the Ending Payment at Maturity:

Index Level of either Index has declined by up to 10% from its respective Initial Index Level, you will receive the principal amount of your Notes at maturity. If the Ending Index Level of either Index declines by more than 10% from its respective Initial Index Level, you will lose 1.1111% of the principal amount of your Notes for every 1% that the Lesser Performing Index

declines beyond 10%, and your payment per \$1,000 principal amount Note will be calculated as follows:

\$1.000 + [\$1.000 x (the Lesser Index Return + 10%) x 1.1111]

where the "Lesser Index Return" is the lower of the Index Return for the S&P 500 Index and the Index Return for the Dow Jones EURO STOXX 50 Index.

Assuming the Notes are not called, you will lose some or all of your investment at maturity at an accelerated rate of 1.1111 times losses in excess of the 10% buffer if the Lesser Index Return

reflects a decline of more than 10%.

## **Hypothetical Total Return Calculations**

The following table illustrates the hypothetical simple total return (i.e., not compounded) on the Notes that could be realized on the applicable Review Date for a range of movements in the Indices as shown under the column "Level of Index with Lesser Return Appreciation/Depreciation at Review Date." For purposes of illustration, the following table assumes that the Index with the lesser return for the entire term of the Notes will be the S&P 500 Index. We make no representation as to which of the Indices will be the Index with the lesser return for purposes of calculating your return on the Notes on any Review Date or at maturity. The following table assumes a Call Level equal to 90% of the hypothetical Initial Index Level for the Index with the lesser return, or 1324.34, for the first and second Review Dates and a Call Level for the final Review Date equal to 100% of the hypothetical Initial Index Level, or 1471.49, for the Index with the lesser return. The table assumes that the percentages used to calculate the Call Premium applicable to the first, second and final Review Dates (as applicable) are 15.00%, 30.00%, and 45.00%, respectively, regardless of the appreciation of the Index with the lesser return, which may be significant; the actual percentages will be determined on the Pricing Date. There will be only one payment on the Notes whether called or at maturity. An entry of "N/A" indicates that the Notes would not be called on the applicable Review Date and no payment would be made for such date. The hypothetical returns set forth below are for illustrative purposes only and may not be the actual total returns applicable to a purchaser of the Notes. For an automatic call to be triggered, the closing level of both Indices must be greater than or equal to their respective Call Levels on one of the Review Dates.

## **Examples**

The following examples illustrate how the total returns set forth in the table above are calculated.

**Example 1**—The level of the Index with the lesser return decreases from the Initial Index Level of 1471.49 to an Index closing level of 1397.92 on the first Review Date. Because the Index closing level of the Index with the lesser return on the first Review Date of 1397.92 is greater than the Call Level of 1324.34, the Notes are automatically called, and the investor receives a single payment of \$1,150 per \$1,000 principal amount Note.

**Example 2**—The level of the Index with the lesser return decreases from the Initial Index Level of 1471.49 to an Index closing level of 1250.77 on the first Review Date, 1250.77 on the second Review Date and 1324.34 on the final Review Date. Because (a) the Index closing level of the Index with the lesser return on the first Review Date of 1250.77 is less than the corresponding Call Level of 1324.34 and the Index closing level of the Index with the lesser return on each of the other Review Dates (1250.77 and 1324.34) is less than the corresponding Call Levels of 1324.34 and 1471.49, and (b) the Ending Index Level of the Index with the lesser return has not declined by more than 10% from the Initial Index Level, the Notes are not called and the payment at maturity is the principal amount of \$1,000 per \$1,000 principal amount Note.

Example 3—The level of the Index with the lesser return decreases from the Initial Index Level of 1471.49 to an Index closing level of 1250.77 on the first Review Date, 1177.19 on the second Review Date and 1030.04 on the final Review Date. Because (a) the Index closing level of the Index with the lesser return on the first Review Date of 1250.77 is less than the corresponding Call Level of 1324.34 and the Index closing level of the Index with the lesser return on each of the other Review Dates (1177.19 and 1030.04) is less than the corresponding Call Levels of 1324.34 and 1471.49, and (b) the Ending Index Level of the Index with the lesser return is more than 10% below the Initial Index Level, the Notes are not called and the investor will receive a payment that is less than the principal amount calculated as follows for each \$1,000 principal amount Note:

 $1,000 + [1,000 \times (-30\% + 10\%) \times 1.1111] = 777.78$ 

## **Selected Purchase Considerations**

**Appreciation Potential**: If the Index closing level of each Index is greater than or equal to the applicable Call Level on a Review Date, your investment will yield a payment per \$1,000 principal amount of Note of \$1,000 plus: (i) at least\* 15.00% x \$1,000 if called on the first Review Date; (ii) at least\* 30.00% x \$1,000 if called on the second Review Date (if applicable); (iii) at least\* 45.00% x \$1,000 if called on the final Review Date. Because the Notes are our senior unsecured obligations, payment of any amount if called or at maturity is subject to our ability to pay our obligations as they become due.

\*The actual percentage applicable to the Review Dates above will be determined on the Pricing Date but will not be less than 15.00%, 30.00%, and 45.00%, respectively.

Potential Early Exit With Appreciation as a Result of Automatic Call Feature While the original term of the Notes is just over 3 years, the Notes will be called before maturity if the Index closing level of both Indices is at or above the applicable Call Level on a Review Date and you will be entitled to the applicable payment set forth on the cover of this term sheet.

Limited Protection Against Loss: If the Notes are not called and neither Ending Index Level declines by no more than 10% as compared to its respective Initial Index Level, you will be entitled to receive the full principal amount of your Notes at maturity. If the Ending Index Level of either Index declines by more than 10%, for every 1% decline of the Lesser Performing Index beyond 10% you will lose an amount equal to 1.1111% of the principal amount of your Notes.

Potential for Early Exit and 90% Return in Year One, Even if the Index Returns for each Index is Negative on the First Review Date. The Call Level for the first Review Date is set at 90% of the Initial Index Level for each Index. Accordingly, you will receive a payment of \$1,150 per \$1,000 principal amount Note after the first Review Date, even if the Index closing level for each Index on the first Review Date reflects a decline of up to 10% from its respective Initial Index Level.

Diversification of the Indices: The return on the Notes is linked to the performance of the Lesser Performing Index of either the S&P 500 Index and the Dow Jones EURO STOXX 50 Index. The S&P 500 Index is published by Standard & Poor's, a division of The McGraw-Hill Companies, Inc. ("Standard & Poor's" or "S&P") and is intended to provide an indication of the pattern of common stock price movement in the United States. The calculation of the level of the S&P 500 Index is based on the relative value of the aggregate market value of the common stocks of 500 companies as of a particular time compared to the aggregate average market value of the common stocks of 500 similar companies during the base period of the years 1941 through 1943. As of August 31, 2007, 426 companies or 85.0% of the market capitalization of the S&P 500 Index traded on the New York Stock Exchange (the "NYSE"); 74 companies or 15.0% of the market capitalization of the S&P 500 Index traded on The Nasdaq Stock Market (the "Nasdaq"); and 0 companies or 0.0% of the market capitalization of the S&P 500 Index traded on the American Stock Exchange ("AMEX"). Ten main groups of companies comprise the Index, with the approximate percentage of the market capitalization of the Index included in each group as of August 31, 2007 indicated in parentheses: Consumer Discretionary (9.8%); Consumer Staples (9.5%); Energy (11.1%); Financials (20.1%); Health Care (11.7%); Industrials (11.4%); Information Technology (16.3%); Materials (3.1%);

Telecommunication Services (3.7%); and Utilities (3.4%). See "The Indices—The S&P 500 Index" in the accompanying product supplement no. RN-3a.

The Dow Jones EURO STOXX 50 Index was created by STOXX Limited to reflect the market-capitalization weighted performance of large companies from the major industry groupings in Austria, Belgium, Finland, France, Germany, Greece, Ireland, Italy, the Netherlands, Portugal and Spain. The companies included in the Dow Jones EURO STOXX 50 Index account for approximately 60% of the free-float market capitalization of the Dow Jones EURO STOXX Total Market Index, which in turn accounts for approximately 95% of the free-float market capitalization of the countries with companies eligible for inclusion in the Dow Jones EURO STOXX 50 Index. The composition of the Dow Jones EURO STOXX 50 Index is reviewed annually, and changes are implemented on the third Friday in September, using market data from the end of August as the basis for the review process. Changes in the composition of the Dow Jones EURO STOXX 50 Index are made to ensure that the Dow Jones EURO STOXX 50 Index in the eligible countries and within each industry sector, have the greatest market capitalization. Changes in the composition of the Dow Jones EURO STOXX 50 Index are made entirely by STOXX without consultation with the companies represented in the Dow Jones EURO STOXX 50 Index or ML&Co. The Dow Jones EURO STOXX 50 Index is also reviewed on an ongoing basis, and a change in the composition of the Dow Jones EURO STOXX 50 Index may be necessary if there have been extraordinary events for one of the issuers of the underlying securities, e.g., delisting, bankruptcy, merger or takeover. In these cases, the event is taken into account as soon as it is effective. The underlying securities may be changed at any time for any reason. See "The Indices—The Dow Jones EURO STOXX 50 Index" in the accompanying product supplement no. RN-3a.

Tax Treatment: You should review carefully the section entitled "United States Federal Income Taxation" in the accompanying product supplement no. RN-3a and MTN prospectus supplement. The pricing of the Notes is subject to delivery of an opinion of our tax counsel, Sidley Austin LLP, that there exists a reasonable basis to characterize and treat the Notes as pre-paid cash-settled forward contracts linked to the levels of the Indices for U.S. federal income tax purposes. The opinion will be subject to the limitations described in the section entitled "Certain United States Federal Income Taxation" in the accompanying product supplement no. RN-3a and will be based on certain factual representations to be received from us on or prior to the Pricing Date. Assuming this characterization and tax treatment is respected, absent a future clarification in current law (by an administrative determination, judicial ruling or otherwise), where required, ML&Co. intends to report your gain or loss on the Notes as long-term capital gain or loss if you hold the Notes for more than a year, whether or not you are an initial purchaser of Notes at the issue price. However, the Internal Revenue Service or a court may not respect this characterization and tax treatment of the Notes, in which case the timing and character of any income or loss on the Notes could be significantly and adversely affected. You should consult your tax adviser regarding the treatment of the Notes, including possible alternative characterizations and tax treatments.

#### **Selected Risk Factors**

An investment in the Notes involves significant risks. Investing in the Notes is not equivalent to investing directly in the Indices or any of the component stocks of the Indices. These risks are explained in more detail in the "Risk Factors" sections of the accompanying product supplement no. RN-3a and MTN prospectus supplement.

#### Your investment may result in a loss

You will not receive interest on the Notes and we will not repay to you a fixed amount of principal on the Notes on the maturity date. The payment on the maturity date will depend on the change in the levels of the Indices. Because the levels of the Indices are subject to market fluctuations, the payment you receive on the maturity date may be more or less than the \$1,000 principal amount per unit. For Notes with a buffer, if the Notes are not called, you will lose some or all of your investment on the maturity date if the Ending Index Level of the Index with the lesser return declines from the Initial Index Level by more than the buffer amount.

#### Your return on the Notes at maturity is linked to the Lesser Performing Index

You may receive a lower payment at maturity than you would have received if you had invested in the Indices individually, the stocks composing the Indices or contracts related to the Indices or their component stocks. An automatic call will be triggered only if both Indices are above their respective Call Levels on one of the Review Dates and, if the Notes are not called, your return on the Notes at maturity will be determined by reference to the Lesser Performing Index. Therefore, your investment in the Notes may not result in a return on such investment even if the Index closing level of one of the two Indices is above its respective Call Level on each Review Date. The two Indices' respective performances may not be correlated and, as a result, your investment in the Notes may only produce a positive return if there is a broad based rise in the performance of equities across diverse markets during the term of the Notes.

### Your return is limited and the Notes are subject to an automatic early call

Your investment in the Notes will result in a gain if the Index closing level of the Lesser Performing Index on any Review Date is greater than or equal to its Call Level on the applicable Review Date. This gain will be limited to the Call Premium applicable to the Review Date on which the Notes are called, regardless of the appreciation of either Index, which may be greater than the applicable Call Premium. In addition, the automatic call feature of the Notes may shorten the term of your investment.

#### Your return, which could be negative, may be lower than the return on other debt securities of comparable maturity

The return that you will receive on your Notes, which could be negative, may be less than the return you could earn on other investments. Your return may be less than the return you would earn if you bought a traditional interest bearing debt security of ML&Co. with the same stated maturity date. Your investment may not reflect the full opportunity cost to you when you take into account factors that affect the time value of money. Unlike traditional interest bearing debt securities, the Notes do not guarantee the return of a principal amount on the maturity date.

## A trading market for the Notes is not expected to develop and the terms of the Notes may affect the secondary market price of the Notes

The Notes will not be listed on any securities exchange, and we do not expect a trading market for the Notes to develop. The limited trading market for the Notes may adversely affect the price that an investor receives for their Notes if they do not wish to hold their investment until the maturity date.

In determining the economic terms of the Notes, and consequently the potential return on the Notes to you, a number of factors are taken into account. Among these factors are certain costs associated with creating, hedging and offering the Notes. In structuring the economic terms of the Notes, we seek to provide investors with what we believe to be commercially reasonable terms and to provide our affiliate MLPF&S with compensation for its services in developing the securities. The price, if any, at which you could sell your Notes in a secondary market transaction is expected to be adversely affected by the factors that we considered in setting the economic terms of the Notes, namely the underwriting discount paid in respect of the Notes and other costs associated with the Notes, and compensation for developing and hedging the product.

#### Your return will not reflect the return of a direct investment in the stocks included in the Indices

You will not have voting rights or rights to receive cash dividends or other ownership rights in the stocks comprising the Indices, and your return on the Notes will not reflect the return you would realize if you actually owned the stocks included in the Indices and received the dividends paid on those stocks, if any, because the level of each Index is calculated by reference to the prices of the stocks included in each Index without taking into consideration the value of dividends paid on those stocks.

## The Index closing levels of either Index will not be adjusted for changes in exchange rates

The stocks composing the Indices are traded in currencies other than U.S. dollars. The Notes, which are linked to the Indices, are denominated in U.S. dollars. The amount payable on the Notes on the maturity date will not be adjusted for changes in the exchange rate between the U.S. dollar and each of the currencies in which the stocks composing the Indices are denominated and therefore the return you receive on the Notes may be adversely affected by changes in the relative value of the U.S. dollar and such other currencies.

#### The trading value of the Notes will be affected by factors that interrelate in complex ways

The effect of one factor may offset the increase in the trading value of the Notes caused by another factor, and the effect of one factor may exacerbate the decrease in the trading value of the Notes caused by another factor. In addition to certain other factors described in the accompanying product supplement no. RN-3a, these factors include changes in (i) the level of the Indices, (ii) interest rates, (iii) the volatility of the Indices, (iv) dividend yields on the stocks included in the Indices and (v) the credit rating of ML&Co.

MLPF&S may also provide a hedge to us against the market risks associated with our obligations under the terms of the Note and MLPF&S or its affiliates may presently or from time to time engage in business with one or more of the companies included in the Index including extending loans to, or making equity investments in, those companies or providing advisory services to those companies, including merger and acquisition advisory services.




