



PRIVATE OFFERING NOTICE

Merrill Lynch & Co., Inc.

Medium-Term Notes, Series C

100% Principal Protected Notes Linked to the 10-Year Constant Maturity Treasury Rate

due June , 2013

(the "Notes")

\$1,000 principal amount per unit

The Notes:

- The Notes are designed for investors who wish to receive quarterly interest income at fixed rate during the initial quarterly interest period and, thereafter, if and to the extent that the 10-Year Constant Maturity Treasury Rate increases from its level on the pricing date of the Notes to the second business day prior to the start of the relevant interest period, and who accept the risk that, on and after September , 2008, the Notes may not yield any return or may yield a rate of return that is below the yield of ML & Co.'s traditional debt securities having comparable maturities.
- Interest on the Notes will be payable quarterly, beginning in September 2008. For the first interest period, interest on the Notes will accrue at 8.00% per annum.
- Thereafter interest on the Notes will be reset quarterly. For each quarterly interest period, interest will accrue at a rate per annum that will equal the amount by which the 10-Year Constant Maturity Treasury Rate exceeds a specified strike rate on the applicable interest determination date immediately preceding the interest period, expressed as percentages, multiplied by a specified leverage factor. The strike rate will equal the 10-Year Constant Maturity Treasury Rate on the pricing date and will be set forth in the final pricing supplement made available in connection with sales of the Notes. The leverage factor will be determined on the pricing date and will be set forth in the final pricing supplement made available in connection with sales of the Notes. The leverage factor is expected to be between 3.75% and 5.75%.
- The Notes are made available to each investor outside of the United States in a minimum initial investment of US\$50,000 (US\$100,000 for residents of the European Economic Area) or other amounts as permitted by local jurisdictions, and subject to any other restrictions, as may be applicable to an investor under the private offering rules of any jurisdiction outside of the United States.
- 100% principal protection on the maturity date.
- The Notes will not be listed on any securities exchange.
- The Notes will be senior unsecured debt securities of Merrill Lynch & Co., Inc., will be part of a series entitled "Medium-Term Notes, Series C". The Notes will have the CUSIP No. .
- The settlement date for the Notes is expected to be June , 2008.

Payment on the maturity date:

- For each \$1,000 principal amount per unit of the Notes, ML & Co. will pay an investor on the maturity date an amount equal to the principal amount per unit, plus any accrued and unpaid interest.

The Notes, the subject of the attached offering document (the "Offering Document"), have not been approved for public sale in any jurisdiction outside of the United States. As such, the Notes are made available to investors outside of the United States only in accordance with applicable private offering rules. The Offering Document may not be copied or otherwise made available to any other person by any recipient without the express written consent of Merrill Lynch & Co., Inc. (the "Company").

No Prospectus (as defined in the EU Prospectus Directive) will be prepared in connection with the Notes. Accordingly, the Notes may not be offered to the public in any European Economic Area ("EEA") member state and any purchaser of the Notes who subsequently sells any of their Notes in any EEA member state must do so only in accordance with the requirements of the Prospectus Directive as implemented in that member state.

The discussion contained in the Offering Document relating to the tax implications of investing in the Notes not based upon, and does not reflect, the tax laws of any jurisdiction outside of the United States. Accordingly, investors should consult their local tax advisor before making an investment in the Notes.

This Notice and the Offering Document have been provided by the Company for informational purposes only. Attention is drawn in particular to the risk factors set forth on pages PS-7 to PS-9 of the attached Pricing Supplement, and pages S-3 to S-4 of the MTN Prospectus Supplement included in the Offering Document. Subject to this Notice, the Offering Document has been approved for issue in the United Kingdom by Merrill Lynch International Bank Limited (“MLIB”), which is authorized and regulated by the Financial Services Authority, with a registered office at Merrill Lynch Financial Center, 2 King Edward Street, London EC1A 1HQ, United Kingdom. This Notice is issued in Hong Kong by Merrill Lynch (Asia Pacific) Limited.

Investors in the United Kingdom should be aware that Merrill Lynch, Pierce, Fenner & Smith Incorporated (“MLPF&S”), which is handling the sale of the Notes, has no place of business in the United Kingdom and is not regulated by the Financial Services Authority. Therefore, with respect to any action taken by MLPF&S, the regulatory regime governing an investor’s rights will be different than that of investors’ rights in the United Kingdom, and the United Kingdom rules for the protection of private investors and the United Kingdom Financial Compensation Scheme will not apply to any business MLPF&S conducts with or for United Kingdom investors.

- (a) The Notes are denominated in United States dollars. Investors that purchase Notes with a currency other than United States dollars should note that changes in rates of exchange may have an adverse effect on the value, price or income of their investment.
