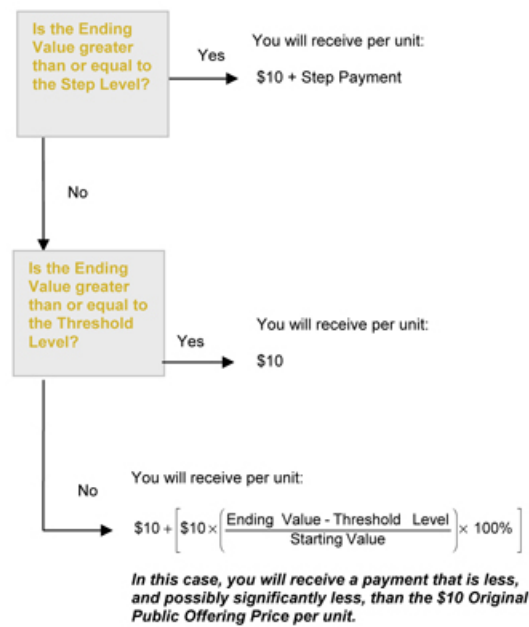
The STEP Income SecuritiesSM Due October , 2009 linked to the common stock of Apple Inc. (the "Notes") are senior, unsecured debt securities of Merrill Lynch & Co., Inc. ("ML&Co.") that are designed for investors who seek quarterly interest payments on their investment and want the opportunity to receive an additional payment at maturity (the "Step Payment") if the Ending Value (as defined below) of the Underlying Stock (as defined below) on the Valuation Date is at or above the Step Level (as defined below). If the Ending Value of the Underlying Stock on the Valuation Date is below the Step Level, the amount you receive on the Maturity Date (the "Redemption Amount") will not be greater than the Original Public Offering Price per unit and will be based on the direction of and percentage change in the level of the Underlying Stock from the Starting Value, as determined on the Pricing Date, to the Ending Value, as determined on the Valuation Date. Investors must be willing to accept a repayment of principal that may be less, and potentially significantly less, than the Original Public Offering Price of the Notes. Investors should be willing to accept that no Step Payment will be payable on the Maturity Date if the closing level of the Underlying Stock is below the Step Level and be willing to lose a portion of their principal if the Ending Value is below the Threshold Level.

Valuation Date:	The fifth scheduled Market Measure Business Day (as defined in product supplement STEPS-1) immediately prior to the maturity date, determined as of the Pricing Date and set forth on the final term sheet made available in connection with sales of the Notes.
Interest:	The Notes will bear interest at a rate of between 8% and 11% of the Original Public Offering Price per year per unit. The actual interest rate will be determined on the Pricing Date and will be set forth in the final term sheet made available in connection with the sale of the Notes. We will pay interest on the Notes quarterly in cash in arrears on January , 2009, April , 2009, July , 2009 and October , 2009.
Step Payment:	If the Ending Value of the Notes is greater than or equal to the Step Level, you will receive an additional payment at Maturity equal to 8% of the Original Public Offering Price per unit (or \$0.80 per unit).
Step Level:	108% to 111% of the Starting Value of the Underlying Stock. The actual Step Level will be determined on the Pricing Date and will be set forth in the final term sheet made available in connection with the sale of the Notes.
Threshold Level:	90% of the Starting Value of the Underlying Stock
Leverage Factor:	100%
Price Multiplier:	1, subject to adjustment for certain corporate events relating to the Underlying Company described in the product supplement STEPS-1.

Determining Payment at Maturity for the Notes

You will receive interest on your Notes at a rate of between 8% and 11% per year, payable quarterly in arrears computed on the basis of a 360-day year of twelve 30-day months. In addition to interest payable, on the Maturity Date you will be entitled to receive the Redemption Amount, a payment per unit calculated as follows:





Hypothetical Payments

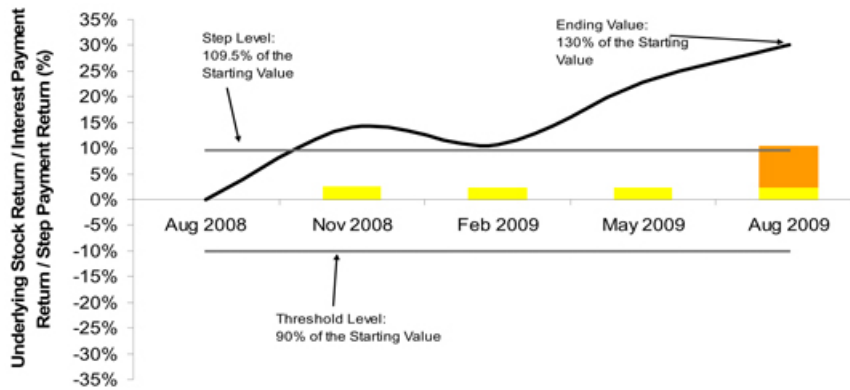
Set forth below are four hypothetical examples of payment calculations related to the Notes. These examples have been prepared for purposes of illustration only. Your actual return will depend on the actual Starting Value, Ending Value, Step Level, Step Payment, interest rate and the term of your investment. These examples assume:

- 1) a hypothetical Starting Value of 175.87, the Volume Weighted Average Price of the Underlying Stock on August 18, 2008;
- 2) a hypothetical Threshold Level of 158.28 (equal to 90% of the hypothetical Starting Value);
- 3) a hypothetical Step Level of 192.58 (equal to 109.5% of the hypothetical Starting Value, the midpoint of the range of 108% and 111%);
- 4) a Step Payment equal to 8% of the \$10 Original Public Offering Price per unit if the Ending Value is greater than or equal to the hypothetical Step Level;
- 5) a term of the Notes from August 19, 2008 to August 26, 2009, a term expected to be similar to that of the Notes; and
- 6) interest payable quarterly in arrears at a rate of 9.5% of the \$10 Original Public Offering Price per unit per annum, the midpoint of the range of 8% and 11%.

Example 1

The hypothetical Ending Value is 228.63 on the Valuation Date (130% of the hypothetical Starting Value).

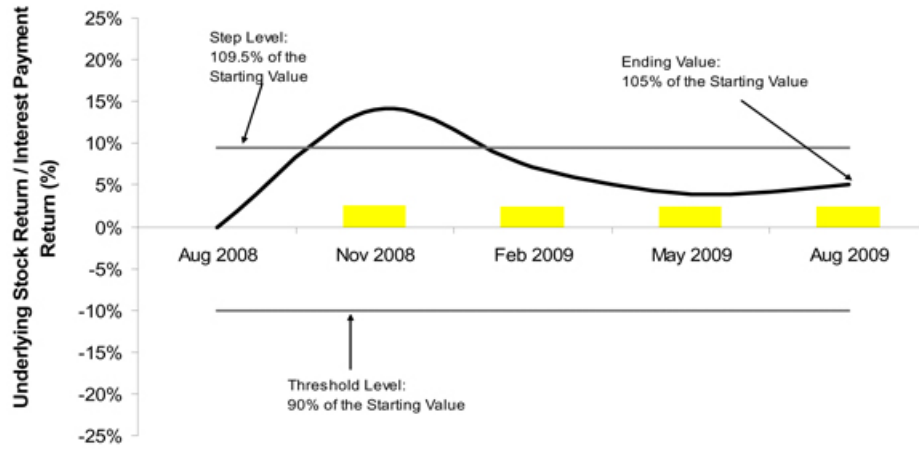
The hypothetical Ending Value of the Underlying Stock on the Valuation Date is greater than the hypothetical Step Level. Consequently, in addition to the quarterly interest payments (represented in yellow below), on the Maturity Date you will receive the Step Payment (represented in orange below). The Redemption Amount per unit on the Maturity Date will therefore be equal to \$10.80 (\$10.00 Original Public Offering Price plus the Step Payment).



Example 2

The hypothetical Ending Value is 184.66 on the Valuation Date (105% of the hypothetical Starting Value)

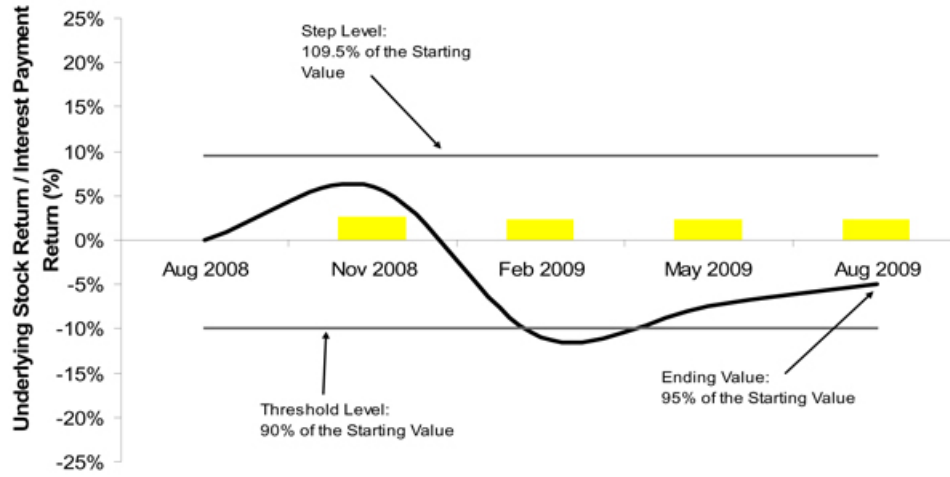
The hypothetical Ending Value of the Underlying Stock on the Valuation Date is greater than the hypothetical Starting Value but below the hypothetical Step Level. Consequently, you will receive the quarterly interest payments (represented in yellow below) but not the Step Payment. The Redemption Amount per unit on the Maturity Date will therefore be equal to the \$10.00 Original Public Offering Price.





Example 3
The hypothetical Ending Value is 167.08 on the Valuation Date (95% of the hypothetical Starting Value)

The hypothetical Ending Value of the Underlying Stock on the Valuation Date is less than the hypothetical Starting Value but above the hypothetical Threshold Level. Consequently, you will receive the quarterly interest payments (represented in yellow below) but not the Step Payment. Because the hypothetical Ending Value is not below the hypothetical Threshold Level, the Redemption Amount per unit on the Maturity Date will be equal to the \$10.00 Original Public Offering Price.



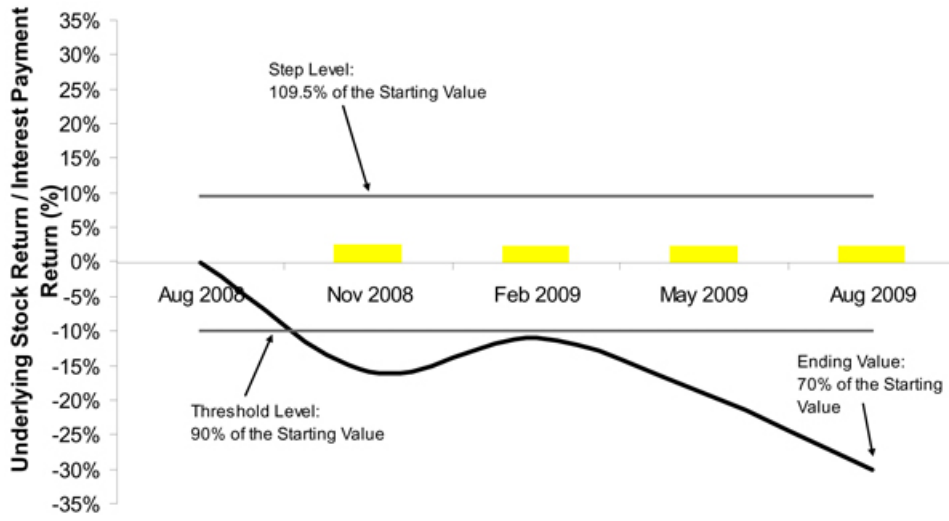
Example 4

The hypothetical Ending Value is 123.11 on the Valuation Date (70% of the hypothetical Starting Value).

The hypothetical Ending Value of the Underlying Stock on the Valuation Date is less than the hypothetical Threshold Level. Consequently, you will receive only the quarterly interest payments (represented in yellow below). You will not receive the Step Payment, and you will participate in the decrease of the Underlying Stock in excess of the hypothetical Threshold Level. The Redemption Amount per unit will equal:

$$\$10 + \left(\$10 \times \left(\frac{123.11 - 158.28}{175.87} \right) \times 100\% \right) = \$8.00$$

On the Maturity Date you will receive the Redemption Amount per unit (\$8.00).

Risk Factors

An investment in the Notes involves significant risks. The following is a list of certain of the risks involved in investing in the Notes. You should carefully review the more detailed explanation of risks relating to the Notes in the "Risk Factors" sections included in the product supplement and MTN prospectus supplement identified below under "Additional Terms of the Notes". We also urge you to consult your investment, legal, tax, accounting and other advisers before you invest in the Notes.

- You will not receive a Step Payment at maturity unless the Ending Value is greater than or equal to the Step Level on the Valuation Date.
- Your investment may result in a loss.
- Your return is limited and will not reflect the return of a direct investment in the Underlying Stock.
- Your return on the Notes, which could be negative, may be lower than the return on other debt securities of comparable maturity.
- You must rely on your own evaluation of the merits of an investment linked to the Underlying Stock.
- In seeking to provide investors with what we believe to be commercially reasonable terms for the Notes while providing MLPF&S with compensation for its services, we have considered the costs of developing, hedging and distributing the Notes. If a trading market develops for the Notes (and such a market may not develop), these costs are expected to affect the market price you may receive or be quoted for your Notes on a date prior to the stated maturity date.
- Many factors affect the trading value of the Notes; these factors interrelate in complex ways and the effect of any one factor may offset or magnify the effect of another factor.
- The Underlying Company will have no obligations relating to the Notes and no diligence will be performed with respect to the Underlying Company.

Investor Considerations

You may wish to consider an investment in the Notes if:

- You anticipate that the closing level of the Underlying Stock on the Valuation Date will be greater than or equal to the Step Level.
- You seek interest payments on your investment.
- You are willing to accept that the maximum return on the Notes is limited to the sum of the quarterly interest payments and the Step Payment, if any.
- You accept that your investment may result in a loss, which could be significant, if the level of the Underlying Stock decreases below the Threshold Level from the Starting Value to the Ending Value.
- You want exposure to the Underlying Stock with no expectation of dividends or other benefits of owning the Underlying Stock.
- You are willing to accept that there is no assurance that the Notes will be listed on NYSE Arca and that any listing will not ensure that a trading market will develop for the Notes or that there will be liquidity in the trading market.

Other Provisions

We may deliver the Notes against payment therefor in New York, New York on a date that is in excess of three business days following the Pricing Date. Under Rule 15c6-1 of the Securities Exchange Act of 1934, trades in the secondary market generally are required to settle in three business days, unless the parties to any such trade expressly agree otherwise. Accordingly, if the initial settlement on the Notes occurs more than three business days from the Pricing Date, purchasers who wish to trade Notes more than three business days prior to the original issue date will be required to specify alternative settlement arrangements to prevent a failed settlement.

If you place an order to purchase these offered securities, you are consenting to each of MLPF&S and its broker-dealer affiliate First Republic Securities Company, LLC acting as a principal in effecting the transaction for your account. MLPF&S is acting as an underwriter and/or selling agent for this offering and will receive underwriting compensation from the issuer of the securities.

Supplement to the Plan of Distribution

MLPF&S and First Republic Securities Company, LLC, each a broker-dealer subsidiary of ML&Co., are members of the Financial Industry Regulatory Authority, Inc. (formerly the National Association of Securities Dealers, Inc. (the "NASD")) and will participate in the distribution of the Notes. Accordingly, offerings of the Notes will conform to the requirements of NASD Rule 2720.

MLPF&S and First Republic Securities Company, LLC may use this Note Prospectus for offers and sales in secondary market transactions and market-making transactions in the Notes but are not obligated to engage in such secondary market transactions and/or market-making transactions. Certain U.S. Federal Income Taxation Considerations

Set forth below is a summary of certain U.S. federal income tax considerations relating to an investment in the Notes. The following summary is not complete and is qualified in its entirety by the discussion under the section entitled "United States Federal Income Taxation" in the accompanying product supplement STEPS-1 and MTN prospectus supplement, which you should carefully review prior to investing in the Notes. Capitalized terms used and not defined herein have the meanings ascribed to them in the accompanying product supplement STEPS-1.

There are no statutory provisions, regulations, published rulings or judicial decisions addressing or involving the characterization and treatment, for U.S. federal income tax purposes, of the Notes or securities with terms substantially the same as the Notes. Accordingly, the proper U.S. federal income tax characterization and treatment of the Notes is uncertain. Pursuant to the terms of the Notes, ML&Co. and every holder of a Note agree (in the absence of an administrative determination, judicial ruling or other authoritative guidance to the contrary) to characterize and treat a Note for all tax purposes as an investment unit consisting of the following components (the "Components"): (i) a debt instrument of ML&Co. (the "Debt Instrument") with a fixed principal amount unconditionally payable on the Maturity Date equal to the Original Public Offering Price of the Notes (i.e., \$10 per unit) and bearing stated interest at the stated interest rate for the Notes and (ii) a cash-settled financial contract (the "Financial Contract") pursuant to which the holder is required to use the principal payment due on the Debt Instrument to make a payment to ML&Co. on the Maturity Date in exchange for cash in an amount equal to the Redemption Amount. Furthermore, based on ML&Co.'s determination of the relative fair market values of the Components at the time of issuance of the Notes, ML&Co. will assign \$_____ of the original issue price of the Notes (i.e., the Original Public Offering Price) to the Debt Instrument and will assign \$_____ of the original issue price of the Notes (i.e., the Original Public Offering Price) to the Financial Contract. Based upon the foregoing, a holder who acquires a Note in connection with the original issuance thereof will be treated as having purchased the Debt Instrument for \$_____ per unit and as having received an initial payment with respect to the Financial Contract in an amount equal to \$_____ per unit.

Due to the absence of authorities that directly address instruments that are similar to the Notes, significant aspects of the U.S. federal income tax consequences of an investment in the Notes are not certain, and no assurance can be given that the Internal Revenue Service (the "IRS") or the courts will agree with the characterization and tax treatment described above. Accordingly, prospective purchasers are urged to consult their own tax advisors regarding the U.S. federal income tax consequences of an investment in the Notes (including alternative characterizations and tax treatments of the Notes) and with respect to any tax consequences arising under the laws of any state, local or foreign taxing jurisdiction.

Possible Future Tax Law Changes. On December 7, 2007, the IRS released a notice that could possibly affect the taxation of holders of the Notes. According to the notice, the IRS and the U.S. Department of the Treasury (the "Treasury Department") are actively considering, among other things, whether the holder of an instrument having terms similar to the Notes should be required to accrue either ordinary income or capital gain (possibly in excess of any interest payments) on a current basis, and they are seeking comments on the subject. It is not possible to determine what guidance they will ultimately issue, if any. It is possible, however, that under such guidance, holders of instruments having terms similar to the Notes will ultimately be required to accrue income currently and this could be applied on a retroactive basis. The IRS and the Treasury Department are also considering other relevant issues, including whether additional gain or loss from such instruments should be treated as ordinary or capital, whether foreign holders of such instruments should be subject to withholding tax on any deemed income accruals, whether the tax treatment of such instruments should vary depending upon whether or not such instruments are traded on a securities exchange, whether such instruments should be treated as indebtedness, whether the tax treatment of such instruments should vary depending upon the nature of the underlying asset, and whether the special "constructive ownership rules" contained in Section 1260 of the Internal Revenue Code of 1986, as amended, might be applied to such instruments. Holders are urged to consult their tax advisors concerning the significance, and the potential impact, if any, of the above considerations to their investment in the Notes. ML&Co. intends to continue to treat the Notes for U.S. federal income tax purposes in accordance with the treatment described herein unless and until such time as the Treasury Department and IRS determine that some other treatment is more appropriate.

Prospective purchasers of the Notes should consult their own tax advisors concerning the tax consequences, in light of their particular circumstances, under the laws of the United States and any other taxing jurisdiction, of the purchase, ownership and disposition of the Notes. See the discussion under the section entitled "United States Federal Income Taxation" in the accompanying product supplement STEPS-1.
