This document supplements the Note Prospectus in connection with any secondary market transactions in the SRNs by Merrill Lynch Pierce, Fenner & Smith Incorporated and its affiliates. Capitalized terms used but not defined in this supplement have the meanings set forth in the Note Prospectus.

The Starting Value for the SRNs was defined in the final pricing supplement relating to the SRNs (the "Final Pricing Supplement"), dated September 22, 2010 and filed with the Securities and Exchange Commission (the "SEC") on September 24, 2010, as the arithmetic average of the closing levels of the Investable Volatility Index™ (the "Index") on September 23, 2010, September 24, 2010, September 28, 2010, and September 29, 2010, which were the first five Calculation Days during the Initial Determination Period on which a market disruption event or a force majeure event did not occur.

The closing levels of the Index on September 23, 2010 was 287.28, September 24, 2010 was 277.47, September 27, 2010 was 278.45, September 28, 2010 was 280.52, and September 29, 2010 was 284.71. Therefore, the Starting Value for the SRNs is 281.69.
