### Summary

The Coupon-Bearing Notes Linked to the common stock of Whole Foods Market, Inc., due March, 2012 (the "notes"), are our senior unsecured debt securities. The notes are not guaranteed or insured by the Federal Deposit Insurance Corporation or secured by collateral. The notes will rank equally with all of our other unsecured and unsubordinated debt, and any payments due on the notes, including any repayment of principal, will be subject to the credit risk of BAC. The notes provide quarterly interest payments. As described in more detail below, if the Ending Value of the Underlying Stock on the Valuation Date is at or above the Threshold Value, you will receive on the maturity date the Original Offering Price per unit. If the Ending Value of the Underlying Stock on the Valuation Date is less than the Threshold Value, the amount you will receive on the maturity date (the "Redemption Amount") will be less than the Original Offering Price per unit and will be based on the percentage change in the price of the Underlying Stock from the Starting Value, as determined on the pricing date, to the Ending Value, as determined on the Valuation Date. Investors must be willing to forgo participation in possible increases in the price of the Underlying Stock and accept a Redemption Amount at maturity that is limited to the Original Offering Price of the notes. Investors must also be willing to accept a Redemption Amount that is less than the Threshold Value.



# Determining the Redemption Amount for the Notes

In addition to interest payable, on the maturity date, you will receive the Redemption Amount, a payment per unit calculated as follows:



In this case, you will receive a payment that is less, and possibly significantly less, than the Original Offering Price per unit.



### **Hypothetical Payments**


Set forth below are three **hypothetical** examples of payment calculations related to the notes. These examples have been prepared for purposes of illustration only. Your actual return will depend on the actual Starting Value, Threshold Value, Ending Value, and the term of your investment. These examples are based on:

- 1) a hypothetical Starting Value of 59.54, which was the Volume Weighted Average Price of the Underlying Stock on February 14, 2011 (rounded to two decimal places);
- 2) a hypothetical Threshold Value of 55.97 (equal to 94% of the hypothetical Starting Value, the midpoint of the Threshold Value range of 92% to 96%, rounded to two decimal places);
- 3) a hypothetical term of the notes from February 21, 2011 to March 1, 2012, a term expected to be similar to that of the notes; and
- 4) interest payable quarterly in arrears at the rate of 8.00% of the Original Offering Price per unit per annum.

#### Example 1

The hypothetical Ending Value is 62.52 (105% of the hypothetical Starting Value)

The hypothetical Ending Value of the Underlying Stock is greater than the hypothetical Starting Value and the hypothetical Threshold Value. Because the hypothetical Ending Value is greater than or equal to the hypothetical Threshold Value, the hypothetical Redemption Amount per unit on the maturity date will be equal to \$10.00. You will receive the quarterly interest payments (represented in yellow below), but you will not participate in the increase in the value of the Underlying Stock.



#### Example 2

The hypothetical Ending Value is 57.16 (96% of the hypothetical Starting Value)

The **hypothetical** Ending Value of the Underlying Stock is less than the **hypothetical** Starting Value, but is greater than the **hypothetical** Threshold Value. Because the **hypothetical** Ending Value is greater than or equal to the **hypothetical** Threshold Value, in addition to the quarterly interest payments (represented in yellow below), the **hypothetical** Redemption Amount per unit on the maturity date will be equal to \$10.00.






#### Example 3

#### The hypothetical Ending Value is 47.63 (80% of the hypothetical Starting Value)

The hypothetical Ending Value of the Underlying Stock is less than the hypothetical Threshold Value. You will receive the quarterly interest payments (represented in yellow below). In addition, you will participate in the percentage decrease of the value of the Underlying Stock in excess of the hypothetical Threshold Value. The hypothetical Redemption Amount per unit (rounded to two decimal places) will equal:

\$10 - 
$$\left[\$10 \times \left(\frac{55.97 - 47.63}{59.54}\right) \times 100\%\right] = \$8.60$$

On the maturity date, you will receive a  $\ensuremath{\text{hypothetical}}$  Redemption Amount per unit of \$8.60.

- You anticipate that the closing price of the Underlying Stock on the Valuation Date will be greater than or equal to the Threshold Value.
- You seek interest payments on your investment.
- You are willing to accept that the maximum return on the notes is limited to the sum of the quarterly interest payments, and that you will have no opportunity to participate in possible increases in the price of the Underlying Stock.
- You accept that your investment will result in a loss, which could be significant, if the closing
  price of the Underlying Stock decreases from the Starting Value to an Ending Value that is
  less than the Threshold Value.
- You seek exposure to the Underlying Stock with no expectation of dividends or other benefits
  of owning shares of the Underlying Stock.

### **Summary Tax Consequences**

You should consider the U.S. federal income tax consequences of an investment in the notes, including the following:

- You agree with us (in the absence of an administrative determination, or judicial ruling to the contrary) to characterize and treat the notes for all tax purposes as income-bearing single financial contracts linked to the Underlying Stock that requires you to pay us at inception an amount equal to the purchase price of the notes and that entitles you to receive the stated periodic interest payments as well as, at maturity, an amount in cash linked to the value of the Underlying Stock.
- Under this characterization and tax treatment of the notes, we intend to take the position that the stated periodic interest payments constitute taxable ordinary income to you, and, upon receipt of a cash payment at maturity or upon a sale or exchange of the notes prior to maturity (other than amounts representing accrued stated periodic interest payments), you generally will recognize capital gain or loss. This capital gain or loss generally will be long-term capital gain or loss if you hold the notes for more than one year.

### Certain U.S. Federal Income Taxation Considerations

Set forth below is a summary of certain U.S. federal income tax considerations relating to an investment in the notes. The following summary is not complete and is qualified in its entirety by the discussion under the section entitled "U.S. Federal Income Tax Summary" beginning on page S-46 of the product supplement Coupon-Bearing Notes-1, which you should carefully review prior to investing in the notes.

General. Although there is no statutory, judicial, or administrative authority directly addressing the characterization of the notes, we intend to treat the notes for all tax purposes as income-bearing single financial contracts linked to the Underlying Stock that requires you to pay us at inception an amount equal to the purchase price of the notes and that entitles you to receive the stated periodic interest payments as well as, at maturity, an amount in cash linked to the value of the Underlying Stock. Under the terms of the notes, we and every investor in the notes agree, in the absence of an administrative determination or judicial ruling to the contrary, to treat the notes as described in the preceding sentence. This discussion assumes that the notes constitute income-bearing single financial contracts, the tax consequences described below would be materially different.

This characterization of the notes is not binding on the Internal Revenue Service ("IRS") or the courts. No statutory, judicial, or administrative authority directly addresses the characterization of the notes or any similar instruments for U.S. federal income tax purposes, and no ruling is being requested from the IRS with respect to their proper characterization and treatment. Due to the absence of authorities on point, significant aspects of the U.S. federal income tax consequences of an investment in the notes are not certain, and no assurance can be given that the IRS or any court will agree with the characterization and tax treatment described in product supplement Coupon-Bearing Notes-1. Accordingly, you are urged to consult your tax advisor regarding all aspects of the U.S. federal income tax consequences of an investment in the notes, including possible alternative characterizations. The discussion in this section and in the section entitled "U.S. Federal Income Tax Summary" beginning on page S-46 of product supplement Coupon-Bearing Notes-1 assume that there is a significant possibility of a significant loss of principal on an investment in the notes.

Stated Periodic Interest Payments. Although the U.S. federal income tax treatment of the stated periodic interest payments on the notes is uncertain, we intend to take the position, and this discussion assumes, that the stated periodic interest payments constitute taxable ordinary income to a U.S. Holder (as defined in product supplement Coupon-Bearing Notes-1) at the time received or accrued in accordance with the U.S. Holder's regular method of accounting.

Settlement at Maturity or Sale or Exchange Prior to Maturity. Assuming that the notes are properly characterized and treated as income-bearing single financial contracts linked to the Underlying Stock for U.S. federal income tax purposes, upon receipt of a cash payment at maturity or upon a sale or exchange of the notes prior to maturity, a U.S. Holder generally will recognize capital gain or loss equal to the difference between the amount realized (other than amounts representing accrued stated periodic interest payments, which would be taxed as described above under "— Stated Periodic Interest Payments") and the U.S. Holder's basis in the notes. This capital gain or loss generally will be long-term capital gain or loss if the U.S. Holder holds the notes for more than one year. The deductibility of capital losses is subject to limitations.

Possible Future Tax Law Changes. From time to time, there may be legislative proposals or interpretive guidance addressing the tax treatment of financial instruments such as the notes. We cannot predict the likelihood of any such legislation or guidance being adopted, or the ultimate impact on the notes. For example, on December 7, 2007, the IRS released Notice 2008-2 ("Notice") seeking comments from the public on the taxation of financial instruments currently taxed as "prepaid forward contracts." The scope of the Notice may extend to instruments similar to the notes. According to the Notice, the IRS and Treasury are considering whether a holder of such instruments should be required to accrue ordinary income on a current basis, regardless of whether any payments are made prior to maturity. It is not possible to determine what guidance the IRS and Treasury will ultimately issue, if any. Any such future guidance may affect the amount, timing, and character of income, gain, or loss in respect of the notes, possibly with retroactive effect. The IRS and Treasury are also considering additional issues, including whether additional gain or loss from such instruments should be treated as ordinary or capital, whether foreign holders of such instruments should be subject to withholding tax on any deemed income accruals, whether Section 1260 of the Internal Revenue Code of 1986, as amended, concerning certain "constructive ownership transactions," generally applies or should generally apply to such instruments, and whether any of these determinations depend on the nature of the underlying asset. ### Market-Linked Investments Classification

Market-Linked Investments come in four basic categories, each designed to meet a different set of investor risk profiles, time horizons, income requirements, and market views (bullish, bearish, moderate outlook, etc.). The following descriptions of these categories are meant solely for informational purposes and are not intended to represent any particular Market-Linked Investment or guarantee performance. #### **Market Downside Protection**

Market Downside Protection Market-Linked Investments combine some of the capital preservation features of traditional bonds with the growth potential of equities and other asset classes. They offer full or partial market downside protection at maturity, while offering market exposure that may provide better returns than comparable fixed income securities. It is important to note that the market downside protection feature provides investors with protection only at maturity, subject to issuer credit risk.
