Summary

The STEP Income Securities® Linked to the Common Stock of The Goodyear Tire & Rubber Company, due July 8, 2013 (the "notes") are our senior unsecured debt securities. The notes are not guaranteed or insured by the Federal Deposit Insurance Corporation or secured by collateral. The notes will rank equally with all of our other unsecured and unsubordinated debt. 


