The Issuer may redeem the Notes at its option, (a) in whole, but not in part, on July 22, 2032, or (b) in whole at any time or in part from time to time, on or after April 22, 2033 and prior to the Maturity Date, in each case, upon at least 5 business days' but not more than 60 calendar days' prior written notice to holders of the Notes at a redemption price equal to 100% of the principal amount of the Notes being redeemed, plus accrued and unpaid interest, if any, thereon to, but excluding, the redemption date.

The Issuer may redeem the Notes, at its option, in whole at any time or in part from time to time, on or after January 22, 2023 (or, if additional Notes are issued after July 22, 2022, on or after the date that is six months after the issue date of such additional Notes), and prior to July 22, 2032, upon at least 5 business days' but not more than 60 calendar days' prior written notice to the holders of the Notes, at a "make-whole" redemption price calculated as set forth in the Prospectus Supplement under "Description of the Notes-Redemption-Make-Whole Redemption." For purposes of the make-whole redemption, the "spread" is 30 basis points.
