

## Terms of the Notes

The Contingent Income Issuer Callable Yield Notes Linked to the Least Performing of the S&P 500® Index, the Russell 2000® Index and the Nasdaq-100® Index (the “Notes”) provide a quarterly Contingent Coupon Payment of \$30.00 on the applicable Contingent Payment Date if, on any quarterly Observation Date, the Observation Value of each Underlying is greater than or equal to its Coupon Barrier. Beginning on May 17, 2021, on each quarterly Call Date thereafter, we have the right to redeem all, but not less than all, of the Notes at 100% of the principal amount, together with the relevant Contingent Coupon Payment. No further amounts will be payable following an Optional Early Redemption. If the Notes are not called, at maturity you will receive the Redemption Amount, calculated as described under “Redemption Amount Determination”.

<b>Term:</b>	Approximately 1.5 years, unless previously called.

<b>Pricing and Issue Dates*:</b>	February 12, 2021 and February 18, 2021, respectively.
<b>Observation Dates†*:</b>	Quarterly. Please see the Preliminary Pricing Supplement for further details.
<b>Coupon Barrier:</b>	For each Underlying, 70% of its Starting Value.
<b>Call Dates*:</b>	Quarterly. Please see the Preliminary Pricing Supplement for further details.
<b>Threshold Value:</b>	For each Underlying, 70% of its Starting Value.
<b>Contingent Coupon Payment*:</b>	If, on any quarterly Observation Date, the Observation Value of each Underlying is greater than or equal to its Coupon Barrier, we will pay a Contingent Coupon Payment of \$30.00 per \$1,000 in principal amount of Notes (equal to a rate of 3.00% per quarter or 12.00% per annum) on the applicable Contingent Payment Date (including the Maturity Date).
<b>Optional Early Redemption:</b>	On any Call Date, we have the right to redeem all (but not less than all) of the Notes at the Early Redemption Amount. No further amounts will be payable following an Optional Early Redemption. We will give notice to the trustee at least five business days but not more than 60 calendar days before the applicable Call Date.
<b>Early Redemption Amount:</b>	For each \$1,000 principal amount of Notes, \$1,000 plus the applicable Contingent Coupon Payment.
<b>Initial Estimated Value Range:</b>	\$955.00-\$995.00 per \$1,000 in principal amount of Notes.
<b>Underwriting Discount*:</b>	\$6.75 (0.675% of the public offering price) per \$1,000 in principal amount of Notes.

- Because the Notes are linked to the least performing (and not the average performance) of the Underlyings, you may not receive any return on the Notes and may lose a significant portion or all of your principal amount even if the Observation Value or Ending Value of one Underlying is always greater than or equal to its Coupon Barrier or Threshold Value, as applicable.
- Your return on the Notes may be less than the yield on a conventional debt security of comparable maturity.
