

## Terms of the Notes

The Contingent Income Auto-Callable Yield Notes Linked to a Basket of Stocks (the "Notes") provide a monthly Contingent Coupon Payment of \$8.3334 on the applicable Contingent Payment Date if, on any monthly Observation Date, the Observation Value of the Basket is greater than or equal to the Coupon Barrier. Beginning in January 2022, if the Observation Value of the Basket is greater than or equal to the Call Value any Observation Date (other than the final Observation Date), the Notes will be automatically called, in whole but not in part, at 100% of the principal amount, together with the relevant Contingent Coupon Payment. No further amounts will be payable following an Automatic Call. If the Notes are not automatically called, at maturity you will receive the Redemption Amount, calculated as described under "Redemption Amount Determination".

Observation Dates†*:	Monthly. Please see the Preliminary Pricing Supplement for further details.
Call Value:	100% of the Starting Value.
Coupon Barrier:	70% of the Starting Value.
Threshold Value:	60% of the Starting Value.
Contingent Coupon Payment*:	If, on any monthly Observation Date, the Observation Value is greater than or equal to the Coupon Barrier, we will pay a Contingent Coupon Payment of \$8.3334 per \$1,000 in principal amount of Notes (equal to a rate of 8.3334% per month or 10.00% per annum) on the applicable Contingent Payment Date (including the Maturity Date).
Automatic Call:	Beginning in January 2022, all (but not less than all) of the Notes will be automatically called if the Observation Value is greater than or equal to the Call Value on any Observation Date (other than the final Observation Date). If the Notes are automatically called, the Early Redemption Amount will be paid on the applicable Contingent Payment Date. No further amounts will be payable following an Automatic Call.
Early Redemption Amount:	For each \$1,000 in principal amount of Notes, \$1,000 plus the applicable Contingent Coupon Payment.
Initial Estimated Value Range:	\$910.00-\$960.00 per \$1,000 in principal amount of Notes.
Underwriting Discount*:	\$30.00 (3.00% of the public offering price) per \$1,000 in principal amount of Notes.
