The S&P 500 <sup>®</sup> Index will be given an initial weight of 60.00%, the EURO STOXX 50 <sup>®</sup> Index will be given an initial weight of 30.00%, and the Russell 2000 <sup>®</sup> Index will be given an initial weight of 10.00%.

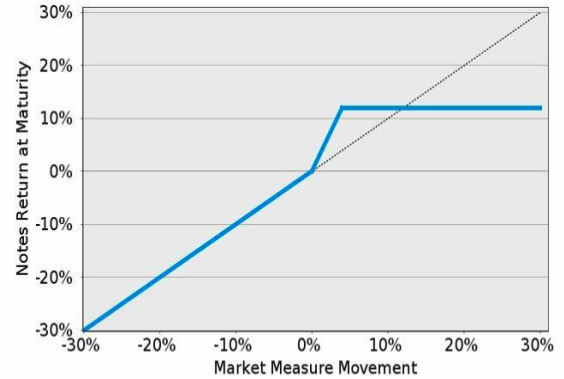
