# **Terms of the Notes**

The Contingent Income Auto-Callable Yield Notes Linked to the Least Performing of the Dow Jones Industrial Average<sup>®</sup>, the Nasdaq-100<sup>®</sup> Index and the Russell 2000<sup>®</sup> Index (the "Notes") provide a monthly Contingent Coupon Payment of \$4.7917 on the applicable Contingent Payment Date if, on any monthly Observation Date, the Observation Value of **each** Underlying is greater than or equal to its Coupon Barrier. Beginning in June 2022, if the Observation Value of **each** Underlying is greater than or equal to 100% of its Starting Value on any applicable quarterly Observation Date (other than the final Observation Date), the Notes will be automatically called, in whole but not in part, at an amount equal to 100% of the principal amount, together with the relevant Contingent Coupon Payment. No further amounts will be payable following an Automatic Call. If the Notes are not automatically called, at maturity you will receive the Redemption Amount, calculated as described under "Redemption Amount Determination".
