

Hypothetical Payout Profile

The profile to the right illustrates the potential payment on the Securities for a range of hypothetical percentage changes in the closing level of the Underlying from the pricing date to the applicable Observation Date. The profile is based on a hypothetical Call Premium of 7.25% for the first Observation Date, 14.50% for the second Observation Date, 21.75% for the third Observation Date and 29.00% for the final Observation Date (based on the specified minimums for the Call Premiums) and a Threshold Value equal to 92.50% of the Starting Value.
