

## Terms of the Notes

The Contingent Income Auto-Callable Yield Notes Linked to the Least Performing of the Dow Jones Industrial Average®, the Nasdaq-100® Index and the Russell 2000® Index (the “Notes”) provide a monthly Contingent Coupon Payment of between [\$6.125 and \$7.7917] on the applicable Contingent Payment Date if, on any monthly Observation Date, the Observation Value of each Underlying is greater than or equal to its Coupon Barrier. The actual Contingent Coupon Payment will be determined on the pricing date. Beginning in May 2023, if the Observation Value of each Underlying is greater than or equal to 100% of its Starting Value on any applicable quarterly Observation Date (other than the final Observation Date), the Notes will be automatically called, in whole but not in part, at an amount equal to 100% of the principal amount, together with the relevant Contingent Coupon Payment. No further amounts will be payable following an Automatic Call. If the Notes are not automatically called, at maturity you will receive the Redemption Amount, calculated as described under “Redemption Amount Determination”.

<b>Term:</b>	Approximately 4.75 years, unless previously automatically called.
<b>Underlyings:</b>	The Dow Jones Industrial Average® (Bloomberg symbol: “INDU”), the Nasdaq-100® Index (Bloomberg symbol: “NDX”) and the Russell 2000® Index (Bloomberg symbol: “RTY”).
<b>Pricing and Issue Dates*:</b>	May 25, 2022 and May 31, 2022, respectively.
<b>Observation Dates*:</b>	Monthly. Please see the Preliminary Pricing Supplement for further details.
<b>Coupon Barrier:</b>	For each Underlying, 75% of its Starting Value.
<b>Threshold Value:</b>	For each Underlying, 60% of its Starting Value.
<b>Call Value:</b>	For each Underlying, 100% of its Starting Value.
<b>Contingent Coupon Payment*:</b>	If, on any monthly Observation Date, the Observation Value of each Underlying is greater than or equal to its Coupon Barrier, we will pay a Contingent Coupon Payment of between [\$6.125 and \$7.7917] per \$1,000 in principal amount of Notes (equal to a rate of between [0.6125% and 0.77917%] per month or between [7.35% and 9.35%] per annum) on the applicable Contingent Payment Date (including the Maturity Date). The actual Contingent Coupon Payment will be determined on the pricing date.
<b>Automatic Call:</b>	Beginning in May 2023, all (but not less than all) of the Notes will be automatically called if the Observation Value of each Underlying is greater than or equal to its Call Value on any applicable quarterly Observation Date (other than the final Observation Date). If the Notes are automatically called the Early Redemption Amount will be paid on the applicable Contingent Payment Date.
<b>Early Redemption Amount:</b>	For each \$1,000 principal amount of Notes, \$1,000 plus the applicable Contingent Coupon Payment.
<b>Initial Estimated Value Range:</b>	\$900-\$950 per Note.
<b>Underwriting Discount*:</b>	\$33.50 (3.35% of the public offering price) per Note.
