

## Terms of the Notes

The Auto-Callable Enhanced Return Notes Linked to the Least Performing of the Russell 2000<sup>®</sup> Index, the Nasdaq-100<sup>®</sup> Index and the Dow Jones Industrial Average<sup>®</sup> (the "Notes") will be automatically called at an amount equal to the Call Amount if the Observation Value of each Underlying on the Observation Date is greater than or equal to its Call Value. No further amounts will be payable following an Automatic Call. If your Notes are not automatically called prior to maturity, at maturity you will receive the Redemption Amount, calculated as described under "Redemption Amount Determination".

If the Notes are automatically called, the Call Amount will be paid on the Call Settlement Date. No further amounts will be payable following an Automatic Call.

- The Notes are subject to a potential Automatic Call, which would limit your ability to receive further payment on the Notes.
- Your return on the Notes may be less than the yield on a conventional debt security of comparable maturity.
