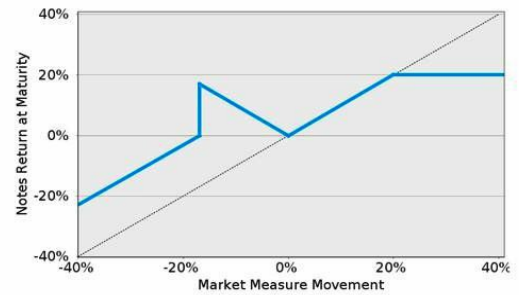

Risk Factors

Please see the Preliminary Offering Documents for a description of certain risks related to this investment, including, but not limited to, the following:

- Depending on the performance of the Market Measure as measured shortly before the maturity date, your investment may result in a loss; there is no guaranteed return of principal.
- Your potential for a positive return based on the depreciation of the Market Measure is limited. The absolute value return feature applies only if the Ending Value is less than the Starting Value but greater than or equal to the Threshold Value. Because the Threshold Value will be [86.00% to 80.00%] of the Starting Value, any positive return due to the depreciation of the Market Measure will be limited to [14.00% to 20.00%]. The actual Threshold Value, and by extension, the cap on the positive return due to the depreciation of the Market Measure, will be determined on the Pricing Date. Any decline in the Ending Value from the Starting Value by more than [14.00% to 20.00%] will result in a loss, rather than a positive return, on the notes.
