

Terms of the Notes

The Contingent Income Auto-Callable Yield Notes Linked to the Least Performing of the Dow Jones Industrial Average®, Nasdaq-100® Index and the Russell 2000® Index (the “Notes”) provide a monthly Contingent Coupon Payment of \$7.083 on the applicable Contingent Payment Date if, on any monthly Observation Date, the Observation Value of each Underlying is greater than or equal to its Coupon Barrier. Beginning in March 2024, if the Observation Value of each Underlying is greater than or equal to 100% of its Starting Value on any of the Observation Dates occurring quarterly indicated by the second footnote appearing below the table beginning on page PS-4 of the preliminary pricing supplement, the Notes will be automatically called, in whole but not in part, at an amount equal to 100% of the principal amount, together with the relevant Contingent Coupon Payment. No further amounts will be payable following an Automatic Call. If the Notes are not automatically called, at maturity you will receive the Redemption Amount, calculated as described under “Redemption Amount Determination”.

| Automatic Call: | Beginning in March 2024, all (but not less than all) of the Notes will be automatically called if the Observation Value of each Underlying is greater than or equal to its Call Value on any of the Observation Dates occurring quarterly indicated by the second footnote appearing below the table beginning on page PS-4 of the preliminary pricing supplement. If the Notes are automatically called the Early Redemption Amount will be paid on the applicable Contingent Payment Date. |
| Early Redemption Amount: | For each \$1,000 principal amount of Notes, \$1,000 plus the applicable Contingent Coupon Payment. |
| Initial Estimated Value Range: | \$900-\$950 per Note. |
| Underwriting Discount*: | \$36.50 (3.65% of the public offering price) per Note. |
