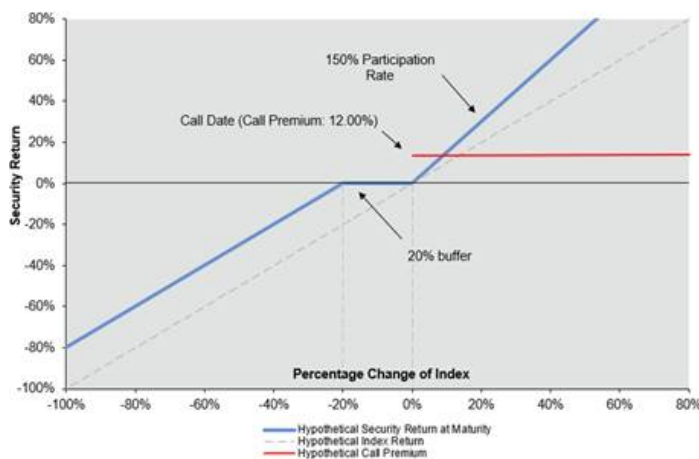

Call Premium:	At least 12.00% of the principal amount
Call Settlement Date:	Five business days after the Call Date.

If the Securities are automatically called, the positive return on the Securities will be limited to the Call Premium, even if the closing level of the Underlying on the Call Date significantly exceeds the Starting Value. If the Securities are automatically called, you will not have the opportunity to participate in any appreciation of the Underlying at the Upside Participation Rate.

If the Securities are not automatically called and the Ending Value is less than the Threshold Value, you will lose more than 20%, and up to 80%, of the principal amount of your Securities on the Maturity Date.

The initial estimated value of the Securities as of the pricing date is expected to be between \$900.00 and \$950.00 per Security, which is less than the public offering price.
