No further payments will be made on the securities once they have been redeemed.
Contingent quarterly coupon:	If, on each index business day during an observation period, the index closing value of each underlying index is greater than or equal to its respective coupon barrier level, we will pay a contingent quarterly coupon of at least \$25.00 per security (equal to a rate of at least 2.50% per quarter or at least 10.00% per annum) on the related coupon payment date. The actual contingent quarterly coupon will be determined on the pricing date. If, on any index business day during an observation period, the index closing value of any underlying index is less than the coupon barrier level for such index, no contingent quarterly coupon will be paid with respect to that observation period. It is possible that one or more underlying indices will close below the respective coupon barrier level(s) on any index business day during most or all of the observation periods throughout the entire term of the securities so that you will receive few or no contingent quarterly coupons.

Under these circumstances, the payment at maturity will be less than 65% of the stated principal amount of the securities and could be zero.
