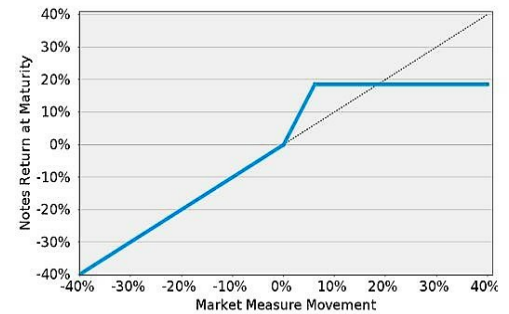

If BofA Finance and BAC become insolvent or are unable to pay their respective obligations, you may lose your entire investment.
