

Jump Securities with Auto-Callable Feature Based on the Performance of the S&P 500[®] Index due January 23, 2034 Fully and Unconditionally Guaranteed by Bank of America Corporation Principal at Risk Securities

This document provides a summary of the terms of the securities. The securities are for investors who are willing to risk their principal and forego current income and participation in the appreciation of the underlying index in exchange for the possibility of receiving an early redemption payment or payment at maturity greater than the stated principal amount if the underlying index closes at or above the initial index value on an annual determination date, respectively. The securities are our senior debt securities. Any payments on the securities are fully and unconditionally guaranteed by Bank of America Corporation ("BAC"). The securities are outs are 1850 Finance LLC's ("BofA Finance") "Medium-Term Notes, Series A" program.
