Investment Summary

Contingent Income Buffered Auto-Callable Securities

Principal at Risk Securities

Contingent Income Buffered Auto-Callable Securities due February 27, 2025 Based on the Performance of the Common Stock of Microsoft Corporation (the "securities") do not provide for the regular payment of interest. Instead, the securities will pay a contingent quarterly coupon (plus any previously unpaid contingent quarterly coupons from prior observation dates) but only if the determination closing price of the shares of Common Stock of Microsoft Corporation, which we refer to as the underlying stock, is at or above 80% of the initial share price, which we refer to as the coupon barrier price, on the related observation date. If, however, the determination closing price of the underlying stock is less than the coupon barrier price on any observation date, we will pay no contingent quarterly coupon for the related quarterly period. The securities will be automatically redeemed if the determination closing price of the underlying stock is greater than or equal to the initial share price on any redemption determination date for the early redemption payment equal to the sum of the stated principal amount plus the related contingent quarterly coupon and any previously unpaid contingent quarterly coupons from prior observation dates. No further payments will be made on the securities once they have been redeemed. At maturity, if the securities have not previously been redeemed and the final share price of the underlying stock is greater than or equal to 80% of the initial share price, meaning that the underlying stock has not declined by an amount greater than the buffer amount of 20%, the payment at maturity will be the stated principal amount and the related contingent quarterly coupon and any previously unpaid contingent quarterly coupons from prior observation dates. However, if the final share price of the underlying stock is less than 80% of the initial share price, meaning that the underlying stock has declined by an amount greater than the buffer amount of 20%, investors will lose approximately 1.25% for every 1% decline in the final share price of the underlying stock from the initial share price beyond the buffer amount of 20%. Accordingly, investors in the securities must be willing to accept the risk of losing their entire initial investment and also the risk of not receiving any contingent quarterly coupons throughout the 1-year term of the securities. Investors will not participate in any appreciation in the price of the underlying stock.

Maturity:	Approximately 1 year
Contingent quarterly coupon:	We will pay a contingent quarterly coupon of \$25.925 per security (equal to a rate of 2.5925% per quarter or 10.37% per annum) on each coupon payment date but only if the determination closing price of the underlying stock is at or above the coupon barrier price on the related observation date. If the contingent quarterly coupon is not paid on any coupon payment date (because the determination closing price of the underlying stock on the related observation date is less than the coupon barrier price), such unpaid contingent quarterly coupon will be paid on a later coupon payment date but only if the determination closing price of the underlying stock on such later observation date is greater than or equal to the coupon barrier price; provided, however, in the case of any such payment of a previously unpaid contingent quarterly coupon, that no additional amounts shall accrue or be payable in respect of such unpaid contingent quarterly coupons if the determination closing price of the underlying stock is less than the coupon barrier price on each subsequent observation date.
Automatic early redemption:	If, on any observation date, the determination closing price of the underlying stock is less than the coupon barrier price, no contingent quarterly coupon will be paid with respect to that observation date. It is possible that the underlying stock will remain below the coupon barrier price for extended periods of time or even throughout the entire 1-year term of the securities so that you will receive few or no contingent quarterly coupons. If the determination closing price of the underlying stock is greater than or equal to the initial share price on any redemption determination date, beginning on May 21, 2024, the securities will be automatically redeemed for an early redemption payment equal to the stated principal amount <i>plus</i> the contingent quarterly coupons with respect to the related observation date and any previously unpaid contingent quarterly coupons from prior observation dates. No further payments will be made on the securities once they have been redeemed.
Payment at maturity:	If the securities have not previously been redeemed and the final share price of the underlying stock is greater than or equal to 80% of the initial share price, meaning that the underlying stock has not declined by an amount greater than the buffer amount of 20%, the payment at maturity will be the stated principal amount and the related contingent quarterly coupon with respect to the final quarterly period and any previously unpaid contingent quarterly coupons from prior observation dates.

The economic terms of the securities are based on BAC's internal funding rate, which is the rate it would pay to borrow funds through the issuance of marketlinked notes, and the economic terms of certain related hedging arrangements BAC's affiliates enter into. BAC's internal funding rate is typically lower than the rate it would pay when it issues conventional fixed or floating rate debt securities. This difference in funding rate, as well as the agent's commissions and fees, if any, and the hedging related charges described below (see "Risk Factors" beginning on page 8), reduced the economic terms of the securities to you and the initial estimated value of the securities. Due to these factors, the public offering price you are paying to purchase the securities is greater than the initial estimated value of the securities as of the pricing date.

Key Investment Rationale

The securities do not provide for the regular payment of interest. Instead, the securities will pay a contingent quarterly coupon (plus any previously unpaid contingent quarterly coupons from prior observation dates) **but only if** the determination closing price of the underlying stock is **at or above the coupon barrier price** on the related observation date. The securities have been designed for investors who are willing to forgo market floating interest rates and risk the loss of principal and accept the risk of receiving few or no coupon payments for the entire 1-year term of the securities in exchange for an opportunity to earn contingent quarterly coupons at a potentially above-market rate if the underlying stock close at or above the coupon barrier price on each observation date, unless the securities are redeemed early. The following scenarios are for illustration purposes only to demonstrate how the coupon and the payment at maturity (if the securities have not previously been redeemed) are calculated, and do not attempt to demonstrate every situation that may occur. Accordingly, the securities may or may not be redeemed, the contingent quarterly coupon may be payable in none of, or some but not all of, the periods during the 1-year term of the securities, and the payment at maturity may be less than the stated principal amount of the securities and may be zero.

Scenario 1: The securities are redeemed prior to maturity	Prior to early redemption, investors receive the contingent quarterly coupon for the periods for which the determination closing price of the underlying stock is at or above the coupon barrier price on the related observation date, but not for the periods for which the determination closing price of the underlying stock is below the coupon barrier price on the related observation date.
	When the underlying stock close at or above the initial share price on a redemption determination date, the securities will be automatically redeemed for the stated principal amount <i>plus</i> the contingent quarterly coupon with respect to the related observation date and any previously unpaid contingent quarterly coupons with respect to any prior observation dates.
Scenario 2: The securities are not redeemed prior to maturity, and investors receive principal back at maturity	This scenario assumes that the underlying stock close at or above the coupon barrier price on some observation dates, but the underlying stock close below the coupon barrier price on the others, and the underlying stock close below the initial share price on every redemption determination date. Consequently, the securities are not redeemed early, and investors receive the contingent quarterly coupon (plus any previously unpaid contingent quarterly coupons from prior observation dates) for the periods for which the determination closing price of the underlying stock is at or above the coupon barrier price on the related observation date, but not for the periods for which the determination closing price of the underlying stock is below the coupon barrier price on the related observation date. On the final observation date, the underlying stock close at or above 80% of the initial share price, meaning that the underlying stock has not declined by an amount greater than the buffer amount of 20%. At maturity, investors will receive the stated principal amount and the related contingent quarterly coupon and any previously unpaid contingent quarterly coupons with respect to any prior observation dates.
Scenario 3: The securities are not redeemed prior to maturity, and investors suffer a loss of principal at maturity	This scenario assumes that the underlying stock close at or above the coupon barrier price on some observation dates, but the underlying stock close below the coupon barrier price on the others, and the underlying stock close below the initial share price on every redemption determination date. Consequently, the securities are not redeemed early, and investors receive the contingent quarterly coupon (plus any previously unpaid contingent quarterly coupons from prior observation dates) for the periods for which the determination closing price of the underlying stock is greater than or equal to the coupon barrier price on the related observation date, but not for the periods for which the determination closing price of the underlying stock is below the coupon barrier price on the related observation date. On the final observation date, the underlying stock close below 80% of the initial share price, meaning that the underlying stock has declined by an amount greater than the buffer amount of 20%. At maturity, investors will lose approximately 1.25% for every 1% decline in the final share price of the underlying stock from the initial share price beyond the buffer amount of 20%. Under these circumstances, the payment at maturity will be less than the stated principal amount and could be zero. No contingent quarterly coupon will be paid at maturity in this scenario and investors will not receive payment for any previously unpaid contingent quarterly coupons.

Hypothetical Examples

The following hypothetical examples illustrate how to determine whether a contingent quarterly coupon is paid with respect to an observation date and how to calculate the payment at maturity, if any, assuming the securities are not redeemed prior to maturity. The following examples are for illustrative purposes only. Whether you receive a contingent quarterly coupon will be determined by reference to the determination closing price of the underlying stock on each observation date, and the amount you will receive at maturity, if any, will be determined by reference to the final share price of the underlying stock on the final observation date. The actual initial share price and coupon barrier price are set forth on the cover of this document. All payments on the securities, if any, are subject to the credit risk of BofA Finance, as issuer, and BAC, as guarantor. The below examples are based on the following terms:

Contingent quarterly coupon:	\$25.925 per security (equal to a rate of 2.5925% per quarter or 10.37% per annum). With respect to each coupon payment date, a contingent quarterly coupon plus any previously unpaid contingent quarterly coupons with respect to any prior observation dates is paid but only if the determination closing price of the underlying stock is at or above the coupon barrier price on the related observation date.

U.S. Holders

This capital gain or loss generally will be long-term capital gain or loss if the U.S. Holder held the securities for more than one year. Alternative Tax Treatments. Due to the absence of authorities that directly address the proper tax treatment of the securities, prospective investors are urged to consult their tax advisors regarding all possible alternative tax treatments of an investment in the securities. In particular, the IRS could seek to subject the securities to the Treasury regulations governing contingent payment debt instruments. If the IRS were successful in that regard, the timing and character of income on the securities would be affected significantly. Among other things, a U.S. Holder would be required to accrue original issue discount every year at a "comparable yield" determined at the time of issuance. In addition, any gain realized by a U.S. Holder at maturity or upon a sale, exchange, or redemption of the securities generally would be treated as ordinary income, and any loss realized at maturity or upon a sale, exchange, or redemption of the securities generally would be treated as ordinary loss to the extent of the U.S. Holder's prior accruals of original issue discount, and as capital loss thereafter.

In addition, it is possible that the securities could be treated as a unit consisting of a deposit and a put option written by the security holder, in which case the timing and character of income on the securities would be affected significantly.

The IRS released Notice 2008-2 (the "Notice") which sought comments from the public on the taxation of financial instruments currently taxed as "prepaid forward contracts." This Notice addresses instruments such as the securities. According to the Notice, the IRS and Treasury are considering whether a holder of an instrument such as the securities should be required to accrue ordinary income on a current basis, regardless of whether any payments are made prior to maturity. It is not possible to determine what guidance the IRS and Treasury will ultimately issue, if any. Any such future guidance may affect the amount, timing and character of income, gain, or loss in respect of the securities, possibly with retroactive effect.

The IRS and Treasury are also considering additional issues, including whether additional gain or loss from such instruments should be treated as ordinary or capital, whether foreign holders of such instruments should be subject to withholding tax on any deemed income accruals, whether Section 1260 of the Code, concerning certain "constructive ownership transactions," generally applies or should generally apply to such instruments, and whether any of these determinations depend on the nature of the underlying asset.

In addition, proposed Treasury regulations require the accrual of income on a current basis for contingent payments made under certain notional principal contracts. The preamble to the regulations states that the "wait and see" method of accounting does not properly reflect the economic accrual of income on those contracts, and requires current accrual of income for some contracts already in existence. While the proposed regulations do not apply to prepaid forward contracts, the preamble to the proposed regulations expresses the view that similar timing issues exist in the case of prepaid forward contracts. If the IRS or Treasury publishes future guidance requiring current economic accrual for contingent payments on prepaid forward contracts, it is possible that you could be required to accrue income over the term of the securities.

Because of the absence of authority regarding the appropriate tax characterization of the securities, it is also possible that the IRS could seek to characterize the securities in a manner that results in tax consequences that are different from those described above. For example, the IRS could possibly assert that any gain or loss that a holder may recognize at maturity or upon the sale, exchange, or redemption of the securities should be treated as ordinary gain or loss.
