**This document provides a summary of the terms of the securities. The securities do not guarantee the repayment of principal and do not provide for the regular payment of interest. Investors will not participate in any appreciation in any underlying index. The securities are for investors who are willing to risk their principal and seek an opportunity to earn contingent quarterly coupon payments at a potentially above-market rate in exchange for the risk of receiving no contingent quarterly coupon payments if any underlying index closes below the coupon barrier level for such index on any index business day during the related observation period, and the risk of an early redemption of the securities at our discretion. The securities are our senior debt securities. Any payments on the securities are fully and unconditionally guaranteed by Bank of America Corporation ("BAC"). The securities are issued as part of BofA Finance LLC's ("BofA Finance") "Medium-Term Notes, Series A" program.

<b>Call feature:</b>	Beginning on January 30, 2025, on any quarterly redemption date, we have the right to redeem all (but not less than all) of the securities for a redemption payment equal to the stated principal amount plus any contingent quarterly coupon otherwise due with respect to the relevant observation period. We will give notice to the trustee at least five business days but not more than 60 calendar days before the applicable redemption date. No further payments will be made on the securities once they have been redeemed.
<b>Contingent quarterly coupon:</b>	If, on each index business day during an observation period, the index closing value of each underlying index is greater than or equal to its respective coupon barrier level, we will pay a contingent quarterly coupon of at least \$20.00 per security (equal to a rate of at least 2.00% per quarter or at least 8.00% per annum) on the related coupon payment date. The actual contingent quarterly coupon will be determined on the pricing date.  If, on any index business day during an observation period, the index closing value of any underlying index is less than the coupon barrier level for such index, no contingent quarterly coupon will be paid with respect to that observation period. It is possible that one or more underlying indices will close below the respective coupon barrier level(s) on any index business day during most or all of the observation periods throughout the entire term of the securities so that you will receive few or no contingent quarterly coupons.
<b>Payment at maturity:</b>	If the securities have not previously been redeemed, investors will receive on the maturity date a payment at maturity determined as follows:  If the final index value of each underlying index is greater than or equal to its respective downside threshold level: the stated principal amount and, if payable, the contingent quarterly coupon otherwise due with respect to the final observation period.  If the final index value of any underlying index is less than its respective downside threshold level: (i) the stated principal amount multiplied by (ii) the index performance factor of the worst performing underlying index. Under these circumstances, the payment at maturity will be less than 65% of the stated principal amount of the securities and could be zero.
<b>Redemption payment:</b>	The redemption payment will be an amount equal to (i) the stated principal amount plus (ii) any contingent quarterly coupon otherwise due with respect to the related observation period.
<b>Initial index value:</b>	For each underlying index, the index closing value on the pricing date.
<b>Final index value:</b>	For each underlying index, the index closing value on the final observation date.
<b>Worst performing underlying index:</b>	The underlying index with the largest percentage decrease from the respective initial index value to the respective final index value.
<b>Index performance factor:</b>	With respect to each underlying index, final index value divided by the initial index value
<b>Redemption dates:</b>	Quarterly. See "Observation Period End-Dates, Coupon Payment Dates and Redemption Dates" below.
<b>Observation period end-dates:</b>	Quarterly, as set forth under "Observation Period End-Dates, Coupon Payment Dates and Redemption Dates" below, subject to postponement as set forth in "Description of the Notes—Certain Terms of the Notes—Events Relating to Observation Dates" beginning on page PS-23 of the accompanying product supplement, with references therein to "Observation Date" to be read as references to "Observation Period End-Date."
<b>Observation period:</b>	Each observation period will consist of each index business day from but excluding an observation period end-date to and including the following observation period end-date, excluding any date or dates that the calculation agent determines is not an index business day with respect to any underlying index; provided that the first observation period will consist of each index business day from but excluding the pricing date to and including the first observation period end-date.
<b>Final observation date:</b>	October 26, 2026, subject to postponement as set forth in "Description of the Notes—Certain Terms of the Notes—Events Relating to Observation Dates" in the accompanying product supplement.
<b>Coupon payment dates:</b>	Quarterly, as set forth under "Observation Period End-Dates, Coupon Payment Dates and Redemption Dates" below.

<b>Coupon barrier level:</b>	For each underlying index, 65% of the initial index value.
<b>Downside threshold level:</b>	For each underlying index, 65% of the initial index value.

## Risk Considerations

### **Structure-related Risks**

- The securities are subject to early redemption, which would limit your ability to receive the contingent quarterly coupons over the full term of the securities
- You may not receive any contingent quarterly coupons.

- The payment at maturity will not reflect changes in the levels of the underlying indices other than on the final observation date.
