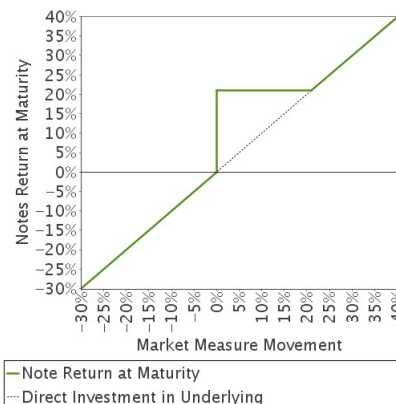

<b>Issuer</b>	Bank of America Corporation ("BAC")
