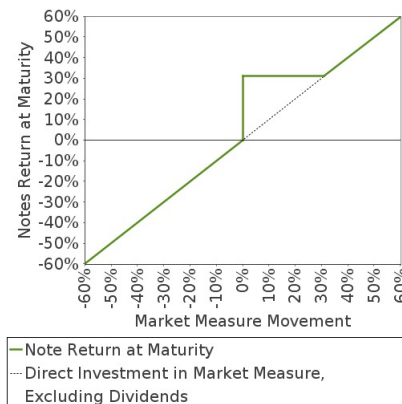

	<b>Autocallable Market-Linked Step Up Notes Linked to the Hang Seng China Enterprises Index</b>
<b>Issuer</b>	BofA Finance LLC ("BofA Finance")
