

Terms of the Notes

The Contingent Income Issuer Callable Yield Notes Linked to the Least Performing of the SPDR® S&P Biotech ETF, the SPDR® S&P Regional Banking ETF and the VanEck® Junior Gold Miners ETF (the "Notes") provide a monthly Contingent Coupon Payment of \$10.209 on the applicable Contingent Payment Date if, on any monthly Observation Date, the Observation Value of each Underlying is greater than or equal to its Coupon Barrier. Beginning on July 10, 2025, and on each monthly Call Date thereafter, we have the right to redeem all, but not less than all, of the Notes at 100% of the principal amount, together with the relevant Contingent Coupon Payment. No further amounts will be payable following an Optional Early Redemption. If the Notes are not called, at maturity you will receive the Redemption Amount, calculated as described under "Redemption Amount Determination".
