Summary of Terms

Issuer and Guarantor:	BofA Finance LLC ("BofA Finance" or "Issuer") and Bank of America Corporation ("BAC" or "Guarantor")
Underlying Stock:	The common stock of Target Corporation
Pricing Date*:	April 21, 2025
Issue Date*:	April 24, 2025
Denominations:	\$1,000 and any integral multiple of \$1,000. References in the pricing supplement to a "Security" are to a Security with a principal amount of \$1,000.
Contingent Coupon Payments:	On each Contingent Coupon Payment Date, you will receive a Contingent Coupon Payment at a per annum rate equal to the Contingent Coupon Rate if, and only if , the stock closing price of the Underlying Stock on the related Calculation Day is greater than or equal to the Coupon Barrier. Each Contingent Coupon Payment, if any, will be calculated per Security as follows: $(\$1,000 \times \text{Contingent Coupon Rate}) / 4$
Contingent Coupon Payment Dates:	Quarterly, on the third business day following each Calculation Day; provided that the Contingent Coupon Payment Date with respect to the Final Calculation Day will be the Maturity Date.
Contingent Coupon Rate:	At least 17.25% per annum, to be determined on the pricing date
Automatic Call:	If the stock closing price of the Underlying Stock on any of the quarterly Calculation Days from July 2025 to January 2028, inclusive, is greater than or equal to the Starting Price, the Securities will be automatically called, and on the related Call Settlement Date you will be entitled to receive a cash payment per Security equal to the principal amount per Security plus a final Contingent Coupon Payment.
Calculation Days*:	Quarterly, on the 21st day of each January, April, July, and October, commencing July 2025 and ending January 2028, and April 21, 2028 (the "Final Calculation Day").
Call Settlement Date:	Three business days after the applicable Calculation Day
Maturity Payment Amount (per Security):	If the Securities are not automatically called, you will receive a Maturity Payment Amount that could be equal to or less than the principal amount per Security, determined as follows: <ul style="list-style-type: none"> if the Ending Price of the Underlying Stock on the Final Calculation Day is greater than or equal to the Threshold Price: \$1,000; or if the Ending Price of the Underlying Stock on the Final Calculation Day is less than the Threshold Price: $\\$1,000 \times \text{Performance Factor of the Underlying Stock on the Final Calculation Day}$
Maturity Date*:	April 26, 2028
Performance Factor:	With respect to the Underlying Stock on any Calculation Day, the stock closing price on such Calculation Day divided by the Starting Price (expressed as a percentage).
Starting Price:	The stock closing price on the pricing date
Ending Price:	The stock closing price on the Final Calculation Day
Coupon Barrier:	60% of the Starting Price
Threshold Price:	60% of the Starting Price

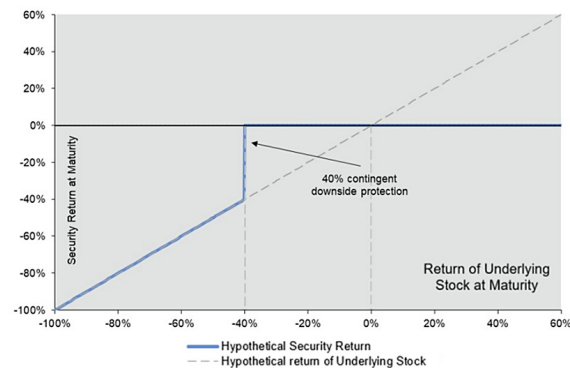

Calculation Agent:	BofA Securities, Inc. ("BofAS"), an affiliate of BofA Finance
Underwriting Discount**:	Up to 2.325% per Security; dealers, including those using the trade name Wells Fargo Advisors (WFA), may receive a selling concession of 1.75% per Security and WFA may receive a distribution expense fee of 0.075% per Security.

If the Securities are not automatically called prior to maturity and the Ending Price of the Underlying Stock on the Final Calculation Day is less than the Threshold Price, you will lose more than 40%, and possibly all, of the principal amount of your Securities at maturity.

Any return on the Securities will be limited to the sum of your Contingent Coupon Payments, if any. You will not participate in any appreciation of the Underlying Stock, but you will have full downside exposure to decreases in the value of the Underlying Stock on the Final Calculation Day if the Ending Price of the Underlying Stock is less than the Threshold Price.

The initial estimated value of the Securities as of the pricing date is expected to be between \$906.75 and \$966.75 per Security, which is less than the public offering price. The actual value of your Securities at any time will reflect many factors and cannot be predicted with accuracy.
