Terms of the Notes

The Notes provide a monthly Maximum Coupon Payment (with Memory) on the applicable Coupon Payment Date if, on the related monthly Observation Date, the Observation Value of each Underlying Stock is greater than or equal to its Coupon Barrier. The monthly Maximum Coupon Payment (with Memory) per \$1,000 in principal amount of Notes for any Coupon Payment Date (including the Maturity Date), will equal (i) the product of \$6.667 times the number of Coupon Payment Dates that have occurred up to the relevant Coupon Payment Date (inclusive of the relevant Coupon Payment Date) minus (ii) the sum of all Coupon Payments previously paid. Otherwise, if the Observation Value of any Underlying Stock on the related Observation Date is less than its Coupon Barrier, the Notes provide a monthly Minimum Coupon Payment of \$0.2084 per \$1,000 in principal amount of Notes on the applicable Coupon Payment Date. If you receive only the Minimum Coupon Payment on any Coupon Payment Date, you will be paid the difference between the Maximum Coupon Payment applicable to a single payment period and the Minimum Coupon Payment for such Coupon Payment Date on a later Coupon Payment Date but only if the Observation Value of each Underlying Stock on the related Observation Date is greater than or equal to 80% of its Starting Value. If the Observation Value of any Underlying Stock on each subsequent Observation Date is less than its Coupon Barrier, then you will only receive the Minimum Coupon Payment for the remaining term of the Notes.

Beginning with the June 25, 2026 Observation Date, if the Observation Value of each Underlying Stock is greater than or equal to its Call Value on any Observation Date (other than the final Observation Date), the Notes will be automatically called, in whole but not in part, at 100% of the principal amount, together with the applicable Coupon Payment. No further amounts will be payable following an Automatic Call. If the Notes are not automatically called prior to maturity, at maturity you will receive the principal amount. At maturity you will also receive the applicable Coupon Payment. Any payments on the Notes depend on the credit risk of BofA Finance, as Issuer, and BAC, as Guarantor, and on the performance of the Underlying Stocks. The economic terms of the Notes are based on BAC's internal funding rate, which is the rate it would pay to borrow funds through the issuance of market-linked notes, and the economic terms of certain related hedging arrangements BAC's affiliates enter into. BAC's internal funding rate is typically lower than the rate it would pay when it issues conventional fixed or floating rate debt securities. This difference in funding rate, as well as the underwriting discount, if any, and the hedging related charges described below (see "Risk Factors" beginning on page PS-13), reduced the economic terms of the Notes to you and the initial estimated value of the Notes. Due to these factors, the public offering price you are paying to purchase the Notes is greater than the initial estimated value of the Notes as of the pricing date.

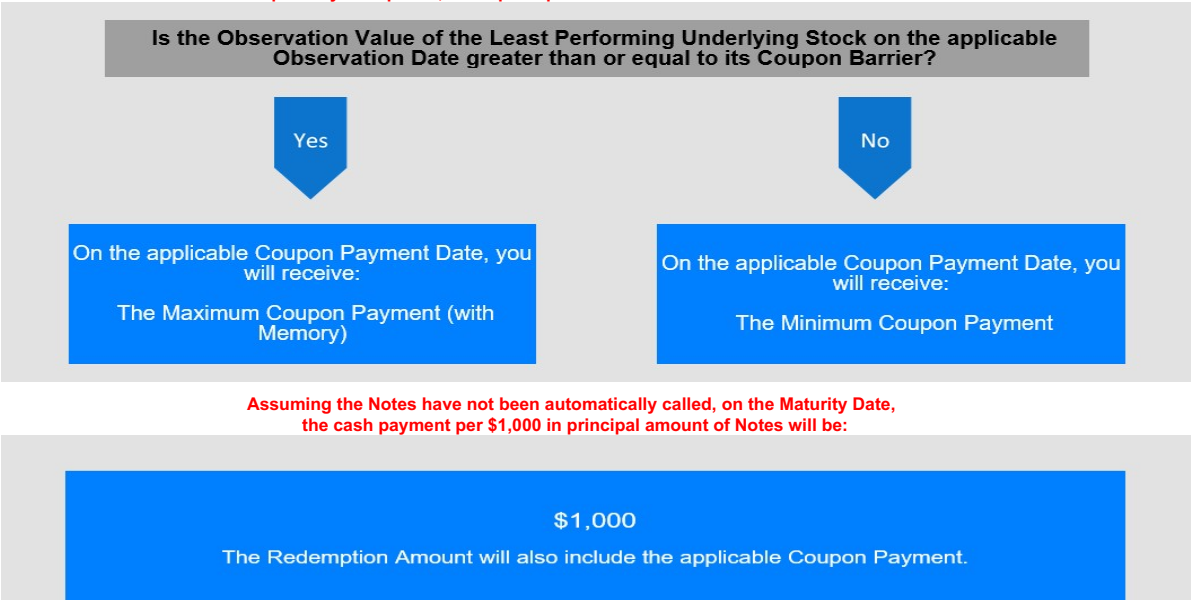

Coupon Payment and Redemption Amount Determination

On each Coupon Payment Date, if the Notes have not been previously called, you will receive a Coupon Payment per \$1,000 in principal amount of Notes determined as follows:



All payments described above are subject to the credit risk of BofA Finance, as issuer, and BAC, as guarantor.



Total Coupon Payment Examples

The examples below illustrate the hypothetical total Coupon Payments per \$1,000.00 in principal amount of Notes over the term of the Notes, based on the Minimum Coupon Payment of \$0.2084 per \$1,000 in principal amount of Notes and the Maximum Coupon Payment (with Memory) per \$1,000.00 in principal amount of Notes equal to (i) the *product* of \$6.667 *times* the number of Coupon Payment Dates that have occurred up to the relevant Coupon Payment Date (inclusive of the relevant Coupon Payment Date) *minus* (ii) the sum of all Coupon Payments previously paid. Depending on the performance of the Underlying Stocks, you may only receive Minimum Coupon Payments during the term of the Notes.

Example 1 - The Observation Value of each Underlying Stock on each of the first through eleventh Observation Dates is below its Coupon Barrier. Therefore, you will only receive Minimum Coupon Payments on the applicable Coupon Payment Dates, resulting in a total of \$2.2924 per \$1,000.00 in principal amount of Notes of Minimum Coupon Payments paid over the course of the first eleven Coupon Payment Dates. The Observation Value of each Underlying Stock on the twelfth Observation Date (which is also the first Call Observation Date) is above its Coupon Barrier but below its Call Value. Therefore, a Maximum Coupon Payment (with Memory) will be paid on the applicable Coupon Payment Date, but the Notes will not be automatically called. The Maximum Coupon Payment (with Memory) per \$1,000.00 in principal amount of Notes due on the related Coupon Payment Date will be calculated as follows:

(i) the *product* of \$6.667 *times* the number of Coupon Payment Dates that have occurred up to the relevant Coupon Payment Date (inclusive of the relevant Coupon Payment Date) *minus* (ii) the sum of all Coupon Payments previously paid.

= (i) $\$6.6670 \times 12$ - (ii) \$2.2924 (the sum of all Coupon Payments previously paid on the first eleven Coupon Payment Dates) = \$77.7116 per \$1,000.00 in principal amount of Notes.

The Observation Value of each Underlying Stock on the thirteenth Observation Date (which is also a Call Observation Date) is above its Coupon Barrier and its Call Value. Therefore, the Notes will be automatically called, and the Maximum Coupon Payment (with Memory) per \$1,000.00 in principal amount of Notes otherwise due on the related Coupon Payment Date will be calculated as follows:

(i) the *product* of \$6.667 *times* the number of Coupon Payment Dates that have occurred up to the relevant Coupon Payment Date (inclusive of the relevant Coupon Payment Date) *minus* (ii) the sum of all Coupon Payments previously paid.

= (i) $\$6.6670 \times 13$ - (ii) \$80.0040 (the sum of all Coupon Payments previously paid on the first twelve Coupon Payment Dates) = \$6.6670 per \$1,000.00 in principal amount of Notes.

On the applicable Coupon Payment Date (which is also the Call Payment Date), you will receive \$1,006.6670 per \$1,000.00 in principal amount of Notes, and no further amounts will be payable on the Notes following an Automatic Call.

Example 2 - The Observation Value of each Underlying Stock on each of the first through eleventh Observation Dates is below its Coupon Barrier. Therefore, you will only receive Minimum Coupon Payments on the applicable Coupon Payment Dates, resulting in a total of \$2.2924 per \$1,000.00 in principal amount of Notes of Minimum Coupon Payments paid over the course of the first eleven Coupon Payment Dates. The Observation Value of each Underlying Stock on the twelfth Observation Date (which is also the first Call Observation Date) is below its Coupon Barrier and its Call Value. Therefore, you will only receive a Minimum Coupon Payment of \$0.2084 per \$1,000.00 in principal amount of Notes on the Coupon Payment Date, and the Notes will not be automatically called. The Observation Value of each Underlying Stock on the thirteenth Observation Date (which is also a Call Observation Date) is above its Coupon Barrier and its Call Value. Therefore, the Notes will be automatically called, and the Maximum Coupon Payment (with Memory) per \$1,000.00 in principal amount of Notes due on the related Coupon Payment Date will be calculated as follows:

(i) the *product* of \$6.667 *times* the number of Coupon Payment Dates that have occurred up to the relevant Coupon Payment Date (inclusive of the relevant Coupon Payment Date) *minus* (ii) the sum of all Coupon Payments previously paid.

= (i) $\$6.6670 \times 13$ - (ii) \$2.5008 (the sum of all Coupon Payments previously paid on the first twelve Coupon Payment Dates) = \$84.1702 per \$1,000.00 in principal amount of Notes.

On the applicable Coupon Payment Date (which is also the Call Payment Date), you will receive \$1,084.1702 per \$1,000.00 in principal amount of Notes, and no further amounts will be payable on the Notes following an Automatic Call.

Example 3 - The Observation Value of each Underlying Stock on each of the first through eleventh Observation Dates is above its Coupon Barrier. Therefore, the Maximum Coupon Payment (with Memory) in the amount of \$6.667 per \$1,000.00 in principal amount of Notes will be paid on each applicable Coupon Payment Date. The Observation Value of each Underlying Stock on the twelfth Observation Date (which is also the first Call Observation Date) is above its Coupon Barrier but below its Call Value. Therefore, a Maximum Coupon Payment (with Memory) will be paid on the applicable Coupon Payment Date, but the Notes will not be automatically called. The Maximum Coupon Payment (with Memory) per \$1,000.00 in principal amount of Notes due on the related Coupon Payment Date will be calculated as follows:



(i) the *product* of \$6.667 times the number of Coupon Payment Dates that have occurred up to the relevant Coupon Payment Date (inclusive of the relevant Coupon Payment Date) minus (ii) the sum of all Coupon Payments previously paid.

= (i) $\$6.667 \times 12$ - (ii) $\$6.667 \times 11$ = \$6.667 per \$1,000.00 in principal amount of Notes.

The Observation Value of each Underlying Stock on each of the thirteenth through fifty-ninth Observation Dates (which are also Call Observation Dates) is above its Coupon Barrier but below its Call Value. Therefore, a Maximum Coupon Payment (with Memory) in the amount of \$6.667 per \$1,000.00 in principal amount of Notes will be paid on each applicable Coupon Payment Date, but the Notes will not be automatically called. The Ending Value of each Underlying Stock on the Valuation Date is above its Coupon Barrier. Therefore, a Maximum Coupon Payment (with Memory) will be due on the Maturity Date, calculated as follows:

(i) the *product* of \$6.667 times the number of Coupon Payment Dates that have occurred up to the relevant Coupon Payment Date (inclusive of the relevant Coupon Payment Date) minus (ii) the sum of all Coupon Payments previously paid.

= (i) $\$6.667 \times 60$ - (ii) $\$6.667 \times 59$ = \$6.667 per \$1,000.00 in principal amount of Notes.

On the Maturity Date, you will receive \$1,006.667 per \$1,000.00 in principal amount of Notes.

Example 4 – The Observation Value of each Underlying Stock on each of the first through seventh Observation Dates is below its Coupon Barrier. Therefore, you will only receive Minimum Coupon Payments on the applicable Coupon Payment Dates, resulting in a total of \$1.4588 per \$1,000.00 in principal amount of Notes of Minimum Coupon Payments paid over the course of the first seven Coupon Payment Dates. The Observation Value of each Underlying Stock on the eighth Observation Date is above its Coupon Barrier. Therefore, a Maximum Coupon Payment (with Memory) will be paid on the applicable Coupon Payment Date. The Maximum Coupon Payment (with Memory) per \$1,000.00 in principal amount of Notes due on the related Coupon Payment Date will be calculated as follows:

(i) the *product* of \$6.667 times the number of Coupon Payment Dates that have occurred up to the relevant Coupon Payment Date (inclusive of the relevant Coupon Payment Date) minus (ii) the sum of all Coupon Payments previously paid.

= (i) $\$6.667 \times 8$ - (ii) \$1.4588 (the sum of all Coupon Payments previously paid on the first seven Coupon Payment Dates) = \$51.8772 per \$1,000.00 in principal amount of Notes.

The Observation Value of each Underlying Stock on each of the ninth through eleventh Observation Dates is above its Coupon Barrier. Therefore, the Maximum Coupon Payment (with Memory) in the amount of \$6.6670 per \$1,000.00 in principal amount of Notes will be paid on the applicable Coupon Payment Dates, resulting in a total of \$20.0010 per \$1,000.00 in principal amount of Notes paid over the course of the ninth through eleventh Coupon Payment Dates. Therefore, a Maximum Coupon Payment (with Memory) will be paid on the applicable Coupon Payment Date, but the Notes will not be automatically called. The Maximum Coupon Payment (with Memory) per \$1,000.00 in principal amount of Notes due on the related Coupon Payment Date will be calculated as follows:

(i) the *product* of \$6.667 times the number of Coupon Payment Dates that have occurred up to the relevant Coupon Payment Date (inclusive of the relevant Coupon Payment Date) minus (ii) the sum of all Coupon Payments previously paid.

= (i) $\$6.6670 \times 12$ - (ii) \$73.3370 (the sum of all Coupon Payments previously paid on the first eleven Coupon Payment Dates) = \$6.6670 per \$1,000.00 in principal amount of Notes.

The Observation Value of each Underlying Stock on each of the thirteenth through fifty-ninth Observation Dates (which are also Call Observation Dates) is below its Coupon Barrier and its Call Value. Therefore, you will only receive Minimum Coupon Payments on the applicable Coupon Payment Dates and the Notes will not be automatically called, resulting in a total of \$9.7948 per \$1,000.00 in principal amount of Notes paid over the course of the thirteenth through fifty-ninth Coupon Payment Dates. The Ending Value of each Underlying Stock on the Valuation Date is above its Coupon Barrier. Therefore, a Maximum Coupon Payment (with Memory) will be due on the Maturity Date, calculated as follows:

(i) the *product* of \$6.667 times the number of Coupon Payment Dates that have occurred up to the relevant Coupon Payment Date (inclusive of the relevant Coupon Payment Date) minus (ii) the sum of all Coupon Payments previously paid.

= (i) $\$6.6670 \times 60$ - (ii) \$89.7988 (the sum of all Coupon Payments previously paid on the first fifty-nine Coupon Payment Dates) = \$310.2212 per \$1,000.00 in principal amount of Notes.

On the Maturity Date, you will receive \$1,310.2212 per \$1,000.00 in principal amount of Notes.

Example 5 – The Observation Value of each Underlying Stock on each of the first through eleventh Observation Dates is below its Coupon Barrier. Therefore, you will only receive Minimum Coupon Payments on the applicable Coupon Payment Dates. The Observation Value of each Underlying



Stock on each of the twelfth through fifty-ninth Observation Dates (which are also the Call Observation Dates) is below its Coupon Barrier and its Call Value. Therefore, you will only receive Minimum Coupon Payments on the applicable Coupon Payment Dates and the Notes will not be automatically called. The Ending Value of each Underlying Stock on the Valuation Date is below its Coupon Barrier. Therefore, you will only receive the Minimum Coupon Payment on the Maturity Date.

Example 6 – The Observation Value of each Underlying Stock on each of the first through eleventh Observation Dates is below its Coupon Barrier. Therefore, you will only receive Minimum Coupon Payments on the applicable Coupon Payment Dates, resulting in a total of \$2.2924 per \$1,000.00 in principal amount of Notes of Minimum Coupon Payments paid over the course of the first eleven Coupon Payment Dates. The Observation Value of each Underlying Stock on each of the twelfth through fifty-eighth Observation Dates (which are also Call Observation Dates) is below its Coupon Barrier and its Call Value. Therefore, you will only receive Minimum Coupon Payments on the applicable Coupon Payment Dates and the Notes will not be automatically called, resulting in a total of \$9.7948 per \$1,000.00 in principal amount of Notes of Minimum Coupon Payments paid over the course of the twelfth through fifty-eighth Coupon Payment Dates. The Observation Value of each Underlying Stock on the fifty-ninth Observation Date (which is also a Call Observation Date) is above its Coupon Barrier but below its Call Value. Therefore, a Maximum Coupon Payment (with Memory) will be paid on the applicable Coupon Payment Date, but the Notes will not be automatically called. The Maximum Coupon Payment (with Memory) per \$1,000.00 in principal amount of Notes due on the related Coupon Payment Date will be calculated as follows:

(i) the *product* of \$6.667 *times* the number of Coupon Payment Dates that have occurred up to the relevant Coupon Payment Date (inclusive of the relevant Coupon Payment Date) minus (ii) the sum of all Coupon Payments previously paid.

= (i) $\$6.6670 \times 59$ - (ii) $\$12.0872$ (the sum of all Coupon Payments previously paid on the first fifty-eight Coupon Payment Dates) = $\$381.2658$ per \$1,000.00 in principal amount of Notes.

The Ending Value of each Underlying Stock on the Valuation Date is below its Coupon Barrier. Therefore, you will only receive the Minimum Coupon Payment on the Maturity Date.

Risk Factors

Your investment in the Notes entails significant risks, many of which differ from those of a conventional debt security. Your decision to purchase the Notes should be made only after carefully considering the risks of an investment in the Notes, including those discussed below, with your advisors in light of your particular circumstances. The Notes are not an appropriate investment for you if you are not knowledgeable about significant elements of the Notes or financial matters in general. You should carefully review the more detailed explanation of risks relating to the Notes in the "Risk Factors" sections beginning on page PS-5 of the accompanying product supplement, page S-6 of the accompanying prospectus supplement and page 7 of the accompanying prospectus, each as identified on page PS-25 below.

Structure-related Risks

- **Your return on the Notes is limited to the return represented by the Coupon Payments over the term of the Notes.** Your return on the Notes is limited to the Coupon Payments paid over the term of the Notes, regardless of the extent to which the Observation Value or the Ending Value of any Underlying Stock exceeds its Coupon Barrier or Starting Value, as applicable. Similarly, the amount payable at maturity or upon an Automatic Call will never exceed the sum of the principal amount and the applicable Coupon Payment, regardless of the extent to which the Observation Value or the Ending Value of any Underlying Stock exceeds its Starting Value. In contrast, a direct investment in the Underlying Stocks would allow you to receive the benefit of any appreciation in their prices. Any return on the Notes will not reflect the return you would realize if you actually owned shares of an Underlying Stock and received the dividends paid or distributions made on them.
- **The Notes are subject to a potential Automatic Call, which would limit your ability to receive the Coupon Payments over the full term of the Notes.** The Notes are subject to a potential Automatic Call. Beginning with the June 25, 2026 Observation Date, the Notes will be automatically called if, on any Observation Date (other than the final Observation Date), the Observation Value of each Underlying Stock is greater than or equal to its Call Value. If the Notes are automatically called prior to the Maturity Date, you will be entitled to receive the principal amount and the applicable Coupon Payment with respect to the applicable Observation Date and no further amounts will be payable following the Automatic Call. In this case, you will lose the opportunity to continue to receive Coupon Payments after the date of the Automatic Call. If the Notes are called prior to the Maturity Date, you may be unable to invest in other securities with a similar level of risk that could provide a return that is similar to the Notes.
- **You may only receive the Minimum Coupon Payments.** The Notes do not provide for any regular fixed coupon payments and may only pay a Minimum Coupon Payment on the applicable Coupon Payment Date or Maturity Date. Investors in the Notes will not necessarily receive any Maximum Coupon Payments (with Memory) over the term of the Notes. If the Observation Value of any Underlying Stock is less than its Coupon Barrier on an Observation Date, you will only receive the Minimum Coupon Payment applicable to that Observation Date. You will receive a Maximum Coupon Payment (with Memory) on a subsequent Coupon Payment Date, which will include an amount equal to the difference between the Maximum Coupon Payment and the Minimum Coupon Payment for each prior Coupon Payment Date on which you received the Minimum Coupon Payment since the last Coupon Payment Date on which the Maximum Coupon Payment (with Memory) was received (or the first Coupon Payment Date if you had not previously received the Maximum Coupon Payment (with Memory) only if the Observation Value of each Underlying Stock on the related Observation Date is greater than or equal to its Coupon Barrier. However, if the Observation Value of any Underlying Stock on an Observation Date is less than its Coupon Barrier and the Observation Value of any Underlying Stock on each subsequent Observation Date up to and including the Valuation Date is less than its Coupon Barrier, you will not receive the difference between the Maximum Coupon Payments (with Memory) and the Minimum Coupon Payments in respect of those Observation Dates. If the Observation Value of any Underlying Stock is less than its Coupon Barrier on all the Observation Dates during the term of the Notes, you will not receive any Maximum Coupon Payments (with Memory) during the term of the Notes.
- **Your return on the Notes may be less than the yield on a conventional debt security of comparable maturity.** Any return that you receive on the Notes may be less than the return you would earn if you purchased a conventional debt security with the same Maturity Date. As a result, your investment in the Notes may not reflect the full opportunity cost to you when you consider factors, such as inflation, that affect the time value of money. In addition, if interest rates increase during the term of the Notes, the Coupon Payment may be less than the yield on a conventional debt security of comparable maturity.
- **The Minimum Coupon Payment, Maximum Coupon Payment (with Memory), Early Redemption Amount or Redemption Amount, as applicable, will not reflect changes in the prices of the Underlying Stocks other than on the Observation Dates.** The prices of the Underlying Stocks during the term of the Notes other than on the Observation Dates will not affect payments on the Notes. The calculation agent will determine the applicable Coupon Payment payable and will calculate the Early Redemption Amount or the Redemption Amount, as applicable, by comparing only the Starting Value, the Call Value or the Coupon Barrier, as applicable, to the Observation Value or the Ending Value for each Underlying Stock. No other prices of the Underlying Stocks will be taken into account.
- **Because the Notes are linked to the least performing (and not the average performance) of the Underlying Stocks, you may not receive any positive return on the Notes beyond the Minimum Coupon Payments.** Your Notes are linked to the least performing of the Underlying Stocks, and a change in the price of one Underlying Stock may not correlate with changes in the prices of the other Underlying Stocks. The Notes are not linked to a basket composed of the Underlying Stocks, where the depreciation in the price of one Underlying Stock could be offset to some extent by the appreciation in the prices of the other Underlying Stocks. In the case of the Notes, the individual performance of each Underlying Stock would not be combined, and the depreciation in the price of one Underlying Stock would not be offset by any appreciation in the prices of the other Underlying Stocks. Even if the Observation Value of an Underlying Stock is at or above its Coupon Barrier on an Observation Date, you will only receive the Minimum Coupon Payment with respect to that Observation Date if the Observation Value of another Underlying Stock is below its Coupon Barrier on that day.



- **Any payments on the Notes are subject to our credit risk and the credit risk of the Guarantor, and any actual or perceived changes in our or the Guarantor's creditworthiness are expected to affect the value of the Notes.** The Notes are our senior unsecured debt securities. Any payment on the Notes will be fully and unconditionally guaranteed by the Guarantor. The Notes are not guaranteed by any entity other than the Guarantor. As a result, your receipt of the Early Redemption Amount or the Redemption Amount at maturity, as applicable, will be dependent upon our ability and the ability of the Guarantor to repay our respective obligations under the Notes on the applicable Coupon Payment Date or the Maturity Date, regardless of the Ending Value of the Least Performing Underlying Stock as compared to its Starting Value or Coupon Barrier. No assurance can be given as to what our financial condition or the financial condition of the Guarantor will be at any time after the pricing date of the Notes. If we and the Guarantor become unable to meet our respective financial obligations as they become due, you may not receive the amount(s) payable under the terms of the Notes.

In addition, our credit ratings and the credit ratings of the Guarantor are assessments by ratings agencies of our respective abilities to pay our obligations. Consequently, our or the Guarantor's perceived creditworthiness and actual or anticipated decreases in our or the Guarantor's credit ratings or increases in the spread between the yield on our respective securities and the yield on U.S. Treasury securities (the "credit spread") prior to the Maturity Date may adversely affect the market value of the Notes. However, because your return on the Notes depends upon factors in addition to our ability and the ability of the Guarantor to pay our respective obligations, such as the prices of the Underlying Stocks, an improvement in our or the Guarantor's credit ratings will not reduce the other investment risks related to the Notes.

- **We are a finance subsidiary and, as such, have no independent assets, operations, or revenues.** We are a finance subsidiary of the Guarantor, have no operations other than those related to the issuance, administration and repayment of our debt securities that are guaranteed by the Guarantor, and are dependent upon the Guarantor and/or its other subsidiaries to meet our obligations under the Notes in the ordinary course. Therefore, our ability to make payments on the Notes may be limited.

Valuation- and Market-related Risks

- **The public offering price you are paying for the Notes exceeds their initial estimated value.** The initial estimated value of the Notes that is provided on the cover page of this pricing supplement is an estimate only, determined as of the pricing date by reference to our and our affiliates' pricing models. These pricing models consider certain assumptions and variables, including our credit spreads and those of the Guarantor, the Guarantor's internal funding rate, mid-market terms on hedging transactions, expectations on interest rates, dividends and volatility, price-sensitivity analysis, and the expected term of the Notes. These pricing models rely in part on certain forecasts about future events, which may prove to be incorrect. If you attempt to sell the Notes prior to maturity, their market value may be lower than the price you paid for them and lower than their initial estimated value. This is due to, among other things, changes in the prices of the Underlying Stocks, changes in the Guarantor's internal funding rate, and the inclusion in the public offering price of the underwriting discount, if any, and the hedging related charges, all as further described in "Structuring the Notes" below. These factors, together with various credit, market and economic factors over the term of the Notes, are expected to reduce the price at which you may be able to sell the Notes in any secondary market and will affect the value of the Notes in complex and unpredictable ways.
- **The initial estimated value does not represent a minimum or maximum price at which we, BAC, BofAS or any of our other affiliates would be willing to purchase your Notes in any secondary market (if any exists) at any time.** The value of your Notes at any time after issuance will vary based on many factors that cannot be predicted with accuracy, including the performance of the Underlying Stocks, our and BAC's creditworthiness and changes in market conditions.
- **We cannot assure you that a trading market for your Notes will ever develop or be maintained.** We will not list the Notes on any securities exchange. We cannot predict how the Notes will trade in any secondary market or whether that market will be liquid or illiquid.

Conflict-related Risks

- **Trading and hedging activities by us, the Guarantor and any of our other affiliates, including BofAS, may create conflicts of interest with you and may affect your return on the Notes and their market value.** We, the Guarantor or one or more of our other affiliates, including BofAS, may buy or sell shares of the Underlying Stocks, or futures or options contracts or exchange traded instruments on the Underlying Stocks, or other instruments whose value is derived from the Underlying Stocks. We, the Guarantor or one or more of our other affiliates, including BofAS, may execute such purchases or sales for our own or their own accounts, for business reasons, or in connection with hedging our obligations under the Notes. These transactions may present a conflict of interest between your interest in the Notes and the interests we, the Guarantor and our other affiliates, including BofAS, may have in our or their proprietary accounts, in facilitating transactions, including block trades, for our or their other customers, and in accounts under our or their management. These transactions may adversely affect the prices of the Underlying Stocks in a manner that could be adverse to your investment in the Notes. On or before the pricing date, any purchases or sales by us, the Guarantor or our other affiliates, including BofAS or others on our or their behalf (including those for the purpose of hedging some or all of our anticipated exposure in connection with the Notes), may have affected the prices of the Underlying Stocks. Consequently, the prices of the Underlying Stocks may change subsequent to the pricing date, which may adversely affect the market value of the Notes.

We, the Guarantor or one or more of our other affiliates, including BofAS, also may have engaged in hedging activities that could have affected the prices of the Underlying Stocks on the pricing date. In addition, these hedging activities, including the unwinding of a hedge, may decrease the market value of your Notes prior to maturity, and may affect the amounts to be paid on the Notes. We, the Guarantor or one or more of our other affiliates, including BofAS, may purchase or otherwise acquire a long or short position in the Notes and may hold or resell the Notes. For example, BofAS may enter into these transactions in connection with any market making activities in which it engages. We cannot assure you that these activities will not adversely affect the prices of the Underlying Stocks, the market value of your Notes prior to maturity or the amounts payable on the Notes.



- **There may be potential conflicts of interest involving the calculation agent, which is an affiliate of ours.** We have the right to appoint and remove the calculation agent. One of our affiliates will be the calculation agent for the Notes and, as such, will make a variety of determinations relating to the Notes, including the amounts that will be paid on the Notes. Under some circumstances, these duties could result in a conflict of interest between its status as our affiliate and its responsibilities as calculation agent.

Underlying Stock-related Risks

- **The terms of the Notes will not be adjusted for all corporate events that could affect an issuer of an Underlying Stock.** The Price Multiplier of an Underlying Stock, the determination of the payments on the Notes, and other terms of the Notes may be adjusted for the specified corporate events affecting the Underlying Stock, as described in the section entitled "Description of the Notes—Anti-Dilution Adjustments" beginning on page PS-23 of the accompanying product supplement. However, these adjustments do not cover all corporate events that could affect the market price of an Underlying Stock, such as offerings of common shares for cash or in connection with certain acquisition transactions. The occurrence of any event that does not require the calculation agent to adjust the applicable Price Multiplier or the amounts that may be paid on the Notes at maturity may adversely affect the price of an Underlying Stock, and, as a result, the market value of the Notes.
 - **AFRM and PLTR have limited actual historical information.** AFRM and PLTR commenced trading recently. Because AFRM and PLTR have limited actual historical performance data with respect to them, your investment in the Notes may involve a greater risk than investing in Notes linked to Underlying Stocks with a more established record of performance.

Tax-related Risks

- **The U.S. federal income tax consequences of an investment in the Notes are uncertain.** However, it would be reasonable to treat your Notes as variable rate debt instruments for U.S. federal income tax purposes. The U.S. federal income tax consequences of an investment in the Notes are not certain. Under the terms of the Notes, you will have agreed with us to treat the Notes as variable rate debt instruments, as described below under "U.S. Federal Income Tax Summary." If you are a secondary purchaser of the Notes, the tax consequences to you may be different. No ruling will be requested from the Internal Revenue Service (the "IRS") with respect to the Notes and no assurance can be given that the IRS will agree with the statements made in the section entitled "U.S. Federal Income Tax Summary." **You are urged to consult with your own tax advisor regarding all aspects of the U.S. federal income tax consequences of investing in the Notes.**

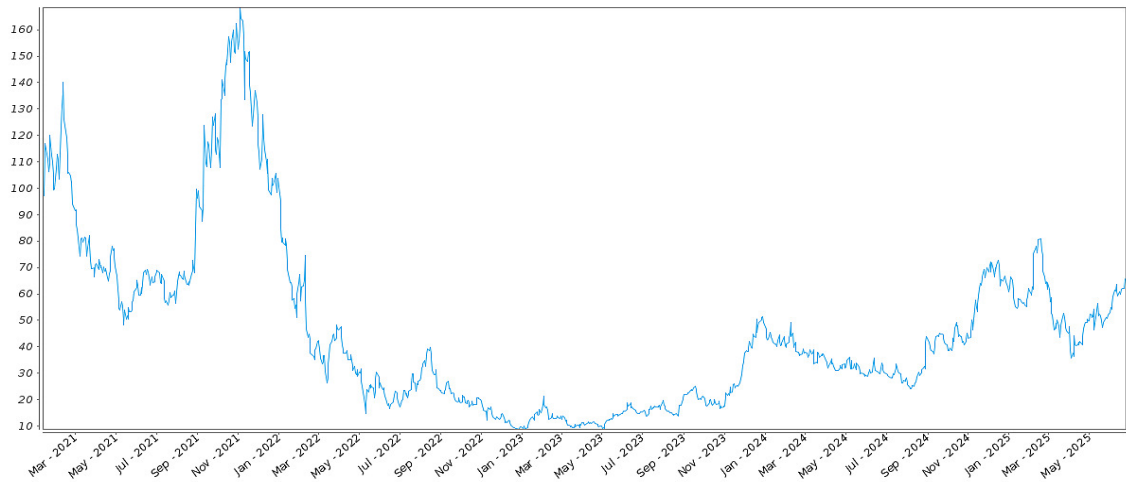

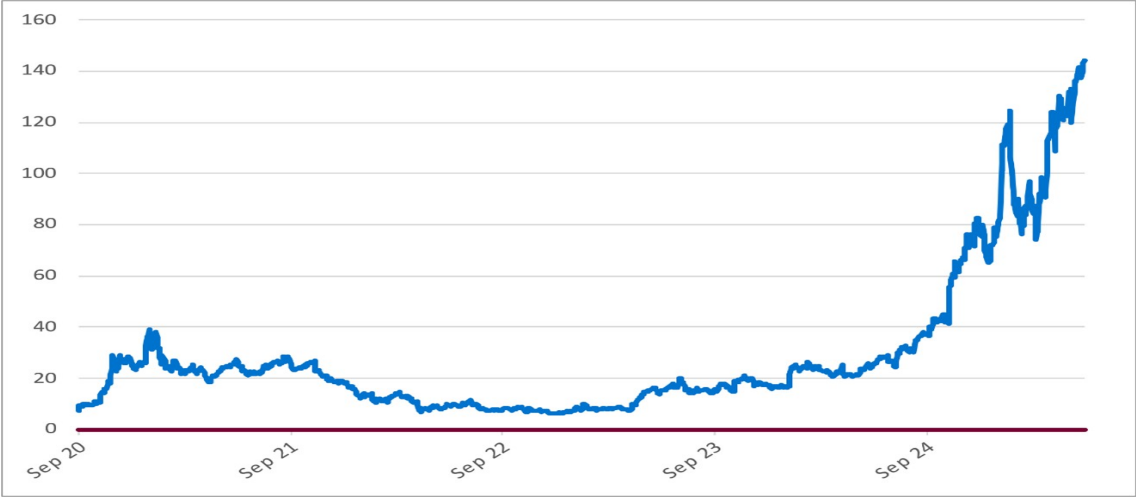

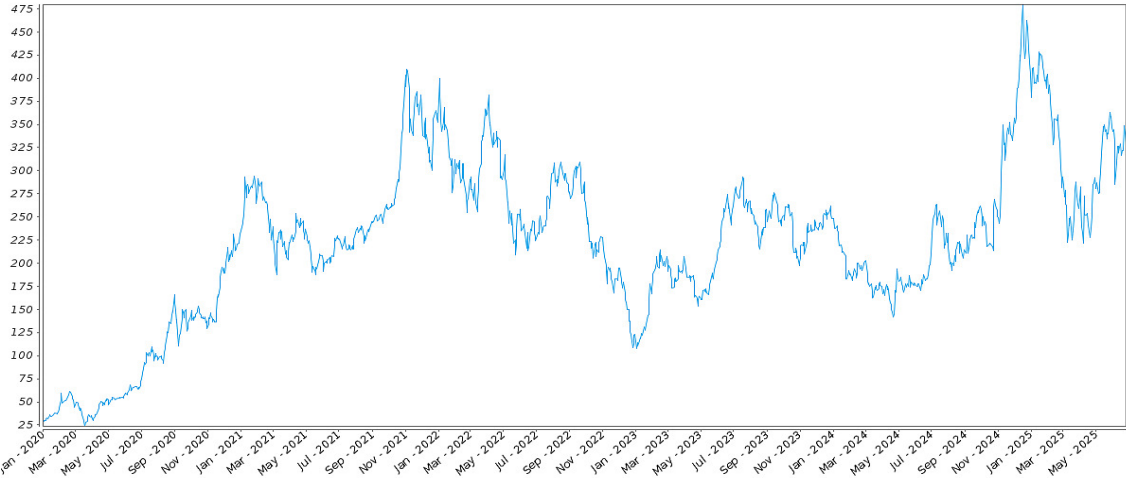

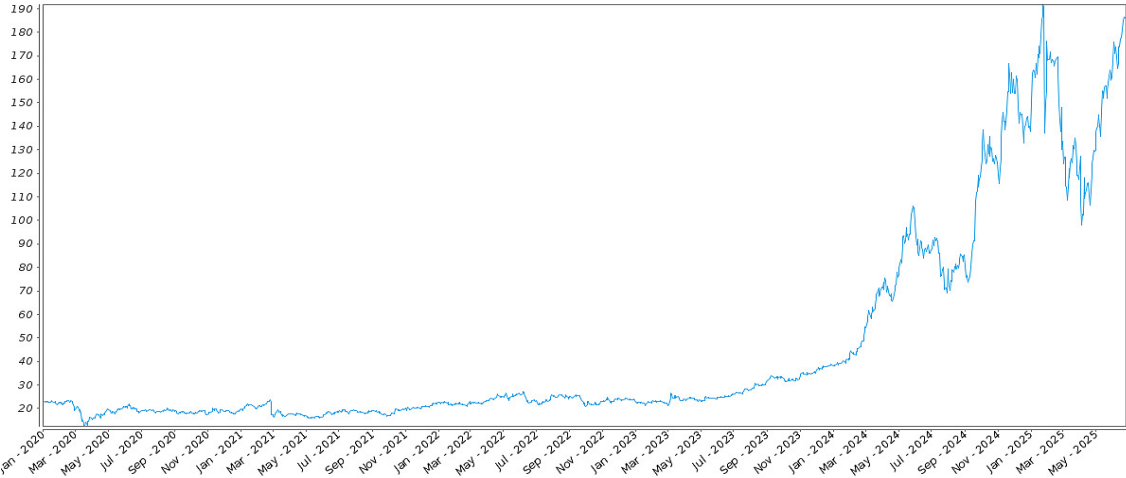

Supplement to the Plan of Distribution; Role of BofAS and Conflicts of Interest

BofAS, a broker-dealer affiliate of ours, is a member of the Financial Industry Regulatory Authority, Inc. ("FINRA") and will participate as selling agent in the distribution of the Notes. Accordingly, the offering of the Notes will conform to the requirements of FINRA Rule 5121. BofAS may not make sales in this offering to any of its discretionary accounts without the prior written approval of the account holder.

Structuring the Notes

The Notes are our debt securities, the return on which is linked to the performance of the Underlying Stocks. The related guarantee is BAC's obligation. As is the case for all of our and BAC's respective debt securities, including our market-linked notes, the economic terms of the Notes reflect our and BAC's actual or perceived creditworthiness at the time of pricing. In addition, because market-linked notes result in increased operational, funding and liability management costs to us and BAC, BAC typically borrows the funds under these types of notes at a rate, which we refer to in this pricing supplement as BAC's internal funding rate, that is more favorable to BAC than the rate that it might pay for a conventional fixed or floating rate debt security. This generally relatively lower internal funding rate, which is reflected in the economic terms of the Notes, along with the fees and charges associated with market-linked notes, resulted in the initial estimated value of the Notes on the pricing date being less than their public offering price.

In order to meet our payment obligations on the Notes, at the time we issue the Notes, we may choose to enter into certain hedging arrangements (which may include call options, put options or other derivatives) with BofAS or one of our other affiliates. This summary is based upon the Internal Revenue Code of 1986, as amended (the “Code”), regulations promulgated under the Code by the U.S. Treasury Department (“Treasury”) (including proposed and temporary regulations), rulings, current administrative interpretations and official pronouncements of the IRS, and judicial decisions, all as currently in effect and all of which are subject to differing interpretations or to change, possibly with retroactive effect. No assurance can be given that the IRS would not assert, or that a court would not sustain, a position contrary to any of the tax consequences described below. This summary does not include any description of the tax laws of any state or local governments, or of any foreign government, that may be applicable to a particular holder.

Although the Notes are issued by us, they will be treated as if they were issued by BAC for U.S. federal income tax purposes. Accordingly throughout this tax discussion, references to “we,” “our” or “us” are generally to BAC unless the context requires otherwise.

This summary is directed solely to U.S. Holders and Non-U.S. Holders that, except as otherwise specifically noted, will purchase the Notes upon original issuance and will hold the Notes as capital assets within the meaning of Section 1221 of the Code, which generally means property held for investment, and that are not excluded from the discussion under “U.S. Federal Income Tax Considerations” in the accompanying prospectus. This discussion does not address the tax consequences applicable to holders subject to Section 451(b) of the Code. This summary assumes that the issue price of the Notes, as determined for U.S. federal income tax purposes, equals the principal amount thereof.

You should consult your own tax advisor concerning the U.S. federal income tax consequences to you of acquiring, owning, and disposing of the Notes, as well as any tax consequences arising under the laws of any state, local, foreign, or other tax jurisdiction and the possible effects of changes in U.S. federal or other tax laws.

U.S. Holders

The tax treatment of your Notes is uncertain. The tax treatment of your Notes will depend upon whether the Notes are properly treated as variable rate debt instruments or contingent payment debt instruments. This in turn depends, in part, upon whether it is reasonably expected that the return on the Notes during the first half of the Notes’ term will be significantly greater or less than the return on the Notes during the second half of the Notes’ term. Based on our numerical analysis, we intend to take the position that it is not reasonably expected that the return on the Notes during the first half of the Notes’ term will be significantly greater or less than the return on the Notes during the second half of the Notes’ term. We accordingly intend to treat your Notes as variable rate debt instruments for U.S. federal income tax purposes.

Except as otherwise noted below under “Alternative Tax Treatments,” the discussion below assumes that the Notes will be treated as variable rate debt instruments for U.S. federal income tax purposes. Under this characterization, interest on a Note generally will be included in the income of a U.S. Holder as ordinary income at the time it is accrued or is received in accordance with the U.S. Holder’s regular method of accounting for U.S. federal income tax purposes. Please see the discussion in the prospectus under the section entitled “U.S. Federal Income Tax Considerations—General—Consequences to U.S. Holders—Variable Rate Debt Securities” for a discussion of these rules.

Upon the sale, exchange, redemption, retirement, or other disposition of a Note, a U.S. Holder will recognize gain or loss equal to the difference between the amount realized upon the sale, exchange, redemption, retirement, or other disposition (less an amount equal to any accrued interest not previously included in income if the Note is disposed of between interest payment dates, which will be included in income as interest income for U.S. federal income tax purposes) and the U.S. Holder’s adjusted tax basis in the Note. A U.S. Holder’s adjusted tax basis in a Note generally will be the cost of the Note to such U.S. Holder. Any gain or loss realized on the sale, exchange, redemption, retirement, or other disposition of a Note generally will be capital gain or loss and will be long-term capital gain or loss if the Note has been held for more than one year. The ability of U.S. Holders to deduct capital losses is subject to limitations under the Code.

Alternative Tax Treatments. If it is determined that it is reasonably expected that the return on the Notes during the first half of the Notes’ term will be significantly greater or less than the return on the Notes during the second half of the Notes’ term, the Notes should be treated as a debt instrument subject to special rules governing contingent payment debt instruments for U.S. federal income tax purposes. If the Notes are so treated, a U.S. Holder would be required to accrue original issue discount every year at a “comparable yield” determined at the time of issuance. In addition, you would be required to construct a projected payment schedule for the Notes and you would make a “positive adjustment” to the extent of any excess of an actual payment over the corresponding projected payment under the Notes, and you would make a “negative adjustment” to the extent of the excess of any projected payment over the corresponding actual payment under the Notes. Any gain realized by a U.S. Holder at maturity or upon a sale, exchange, or redemption of the Notes generally would be treated as ordinary income, and any loss realized at maturity or upon a sale, exchange, or redemption of the Notes generally would be treated as ordinary loss to the extent of the U.S. Holder’s prior accruals of original issue discount, and as capital loss thereafter.



It is also possible that the IRS could determine that the Notes should be subject to special rules for Notes that provide for alternative payment schedules if one of such schedules is significantly more likely than not to occur. If your Notes are subject to those rules, you would generally be required to include the stated interest on your Notes in income as it accrues even if you are otherwise subject to the cash basis method of accounting for tax purposes. The rules for Notes that provide alternative payment schedules if one of such schedules is significantly more likely than not to occur are discussed under "U.S. Federal Income Tax Considerations—General—Consequences to U.S. Holders—Debt Securities Subject to Contingencies" in the accompanying prospectus.

Non-U.S. Holders

A "dividend equivalent" payment is treated as a dividend from sources within the United States and such payments generally would be subject to a 30% U.S. withholding tax if paid to a Non-U.S. Holder. Under Treasury regulations, payments (including deemed payments) with respect to equity-linked instruments ("ELIs") that are "specified ELIs" may be treated as dividend equivalents if such specified ELIs reference an interest in an "underlying security," which is generally any interest in an entity taxable as a corporation for U.S. federal income tax purposes if a payment with respect to such interest could give rise to a U.S. source dividend. However, IRS guidance provides that withholding on dividend equivalent payments will not apply to specified ELIs that are not delta-one instruments and that are issued before January 1, 2027. Based on our determination that the Notes are not delta-one instruments, Non-U.S. Holders should not be subject to withholding on dividend equivalent payments, if any, under the Notes. However, it is possible that the Notes could be treated as deemed reissued for U.S. federal income tax purposes upon the occurrence of certain events affecting the Underlying Stocks or the Notes, and following such occurrence the Notes could be treated as subject to withholding on dividend equivalent payments. Non-U.S. Holders that enter, or have entered, into other transactions in respect of the Underlying Stocks or the Notes should consult their tax advisors as to the application of the dividend equivalent withholding tax in the context of the Notes and their other transactions. If any payments are treated as dividend equivalents subject to withholding, we (or the applicable paying agent) would be entitled to withhold taxes without being required to pay any additional amounts with respect to amounts so withheld.
