- (1) The 1,000 variable rate muni term preferred shares reported as disposed of in Table I (the "VMTP Shares") represent shares that were beneficially owned by Banc of America Preferred Funding Corporation ("PFC"). The VMTP Shares were disposed of as a result of a sale of the VMTP Shares for a price of \$100,052.84932 per share (which includes a liquidation preference of \$100,000.00 per share and accrued dividends of \$52.84932 per share). PFC is a wholly owned subsidiary of Bank of America Corporation.
- (2) This statement is jointly filed by Bank of America Corporation and PFC. Bank of America Corporation held an indirect interest in the securities listed in Table I by virtue of its indirect ownership of its subsidiary PFC.
