- In connection with the reorganization of Nuveen Maryland Quality Municipal Income Fund ("NMY") into the Issuer, 1,820 adjustable rate munifund term preferred shares (1) ("AMTP Shares"), Series 2028, of NMY beneficially owned by Banc of America Preferred Funding Corporation ("PFC") were exchanged for an equal number of AMTP Shares, Series 2028-2, of the Issuer in a cashless transaction. The 1,820 shares reported as acquired in Table I represent shares beneficially owned by PFC.
- In addition to the 1,820 AMTP Shares, Series 2028-2, reported as acquired in Table I above by PFC, PFC holds 5,455 AMTP Shares and 720 munifund preferred shares (2) ("MFP Shares") of the Issuer. The 5,455 AMTP Shares were previously acquired by PFC as reported in the Form 4 filing filed by Bank of America Corporation and PFC with the United States Securities and Exchange Commission filed December 17, 2018 and the 720 MFP Shares were previously acquired by PFC as reported in the Form 4 filing filed by Bank of America Corporation and PFC with the United States Securities and Exchange Commission filed February 20, 2020.
- (3) This statement is jointly filed by Bank of America Corporation and PFC. Bank of America Corporation held an indirect interest in the securities listed in Table I by virtue of its indirect ownership of its subsidiary PFC.
