The Notes:

- The Notes are designed for investors who anticipate that the sum of the weighted returns (the "Cumulative Return") of the exchange rates of the Brazilian real, Russian ruble, Indian rupee and Chinese renminbi (yuan) (each, an "Underlying Currency" and together, the "Underlying Currencies") relative to the United States dollar will be positive or zero, as more fully described in the attached offering document. The Cumulative Return will increase if the values of the Underlying Currencies appreciate relative to the United States dollar over the term of the Notes. The Cumulative Return will decrease if the values of the Underlying Currencies depreciate relative to the United States dollar over the term of the Notes.
- The Notes will have 100% principal protection on the maturity date.
- Because Merrill Lynch & Co., Inc. will make no payments on the Notes prior to the maturity date, investors must be willing to forgo periodic payments of interest.
- The Notes will not be redeemable prior to the maturity date.
- · The Notes will not be listed on any securities exchange.
- The Notes are made available to each investor outside of the United States in a
 minimum initial investment of US\$50,000 (or US\$100,000 for residents of the
 European Economic Area) or other amounts as permitted by local jurisdictions,

 - positive and greater than a threshold percentage of between 20% and 30% (the "Threshold Percentage"), investors will receive the \$10 principal amount per unit plus an amount per unit equal to \$10 multiplied by 100% of the Cumulative Return:
 - zero or positive but less than or equal to the Threshold Percentage, investors
 will receive the \$10 principal amount per unit plus an amount per unit equal to
