### Private Offering Notice Summary Terms

#### The Notes:

- The Notes are designed for investors who want exposure to equities, fixed income and commodities asset classes and who believe that the value of at least one of three baskets, comprised of a mix of these three asset classes and weighted according to an investment approach, will increase from the pricing date to a date shortly before the maturity date. Each basket will be comprised of the same seven market measures encompassing the three asset classes. As more fully described in the attached offering document, each basket will have a conservative, balanced or aggressive investment approach and each asset class will be weighted differently within each basket according to the investment approach associated with the basket. The equity asset class will be represented by the S&P 500<sup>®</sup> Index (index symbol “SPX”), the Dow Jones Euro STOXX 50<sup>SM</sup> Index (index symbol “SX5E”) and the Nikkei 225<sup>®</sup> Index (index symbol “NKY”). The fixed income asset class will be represented by the Dow Jones CBOT Treasury Index (index symbol “DJCBTI”). The commodity asset class will be represented by the Merrill Lynch Commodity index eXtra Agriculture Excess Return Index (index symbol “MLCXAGER”), the Merrill Lynch Commodity index eXtra Precious Metals Excess Return Index (index symbol “MLCXPMER”) and the Merrill Lynch Commodity index eXtra Crude Oil Excess Return Index (index symbol “MLCXCLER”).
- The Notes are made available to each investor outside of the United States in a minimum initial investment of US\$100,000 or other amounts as permitted by local jurisdictions, and subject to any other restrictions, as may be applicable to an investor under the private offering rules of any jurisdiction outside of the United States.
- The term of the Notes will be between 38 to 42 months.
- 100% principal protection on the maturity date.
- There will be no payments on the Notes prior to the maturity date and we cannot redeem the Notes prior to the maturity date.
- The Notes will not be listed on any securities exchange.
- The Notes will be senior unsecured debt securities of Merrill Lynch & Co., Inc., denominated and payable in United States dollars, and part of a series entitled “Medium-Term Notes, Series C”. Any payments due on the Notes will be subject to the credit risk of Merrill Lynch & Co., Inc. The Notes will have the CUSIP No \_\_\_\_\_.
- The Notes are not guaranteed or insured by the Federal Deposit Insurance Corporation.
- The settlement date for the Notes is expected to be October \_\_\_\_\_, 2008.

#### Payment on the maturity date:

- The amount an investor receives on the maturity date per unit will be based upon the direction of and percentage change in the value of the best performing basket from the starting value of such basket on the pricing date to the ending value of such basket on a date shortly prior to the maturity date. If the value of the best performing basket:
  - has increased, an investor will receive the \$10 principal amount per unit, plus a supplemental redemption amount per unit of \$10 multiplied by the percentage increase; or
  - has decreased or is unchanged, an investor will receive the \$10 principal amount per unit.
